INHERITANCE LAWS IN MESOPOTAMIA

MESOPOTAMIA, OFTEN REGARDED AS THE CRADLE OF CIVILIZATION, DEVELOPED SOME OF THE EARLIEST RECORDED INHERITANCE LAWS. THE CODE OF HAMMURABI, DATING BACK TO AROUND 1754 BCE, PROVIDES A DETAILED LEGAL FRAMEWORK FOR INHERITANCE AND PROPERTY TRANSFER AMONG THE ANCIENT BABYLONIANS.

- DEBTS OWED BY THE DECEASED COULD BE CLAIMED FROM THE ESTATE BEFORE DISTRIBUTION TO HEIRS.

EGYPTIAN INHERITANCE TRADITIONS

INHERITANCE DISPUTES WERE RESOLVED BY LOCAL COURTS, WHERE EVIDENCE SUCH AS WILLS AND WITNESSES PLAYED AN IMPORTANT ROLE. THE CONCEPT OF MA'AT, REPRESENTING ORDER AND JUSTICE, UNDERScoreD THE IMPORTANCE OF FAIR INHERITANCE PRACTICES.

GREEK AND ROMAN SUCCESSION PRACTICES

ANCIENT GREECE AND ROME DEVELOPED SOPHISTICATED LEGAL SYSTEMS GOVERNING INHERITANCE THAT INFLUENCED WESTERN LEGAL TRADITIONS. BOTH CULTURES EMPHASIZED THE CONTINUITY OF FAMILY LINES AND THE PRESERVATION OF PROPERTY WITHIN THE GENS OR CLAN.

GENDER AND LINEAGE IN ANCIENT INHERITANCE
