THE CREATION OF THE U.S. CONSTITUTION LAID A FOUNDATION FOR DEMOCRATIC GOVERNANCE.

THE FRENCH REVOLUTION

THE FRENCH REVOLUTION (1789–1799) WAS A RADICAL POLITICAL AND SOCIAL UPEAVAL THAT DISMANTLED THE ABSOLUTE MONARCHY AND FEUDAL PRIVILEGES. LEADERS SUCH AS SIMÓN BOLÍVAR AND JOSÉ DE SAN MARTÍN SPEARHEADED LIBERATION MOVEMENTS AGAINST SPANISH AND PORTUGUESE COLONIAL RULE. THESE REVOLUTIONS RESULTED IN THE CREATION OF NEW NATIONS, THOUGH POLITICAL INSTABILITY AND SOCIAL STRATIFICATION PERSISTED IN MANY AREAS.

THE INDUSTRIAL REVOLUTION

THE INDUSTRIAL REVOLUTION REPRESENTS A TRANSFORMATIVE PHASE IN AP WORLD HISTORY CHAPTER 22, MARKING THE SHIFT FROM AGRARIAN ECONOMIES TO INDUSTRIALIZED SOCIETIES. INDUSTRIALIZATION IN EUROPE AND BEYOND

WHILE GREAT BRITAIN LED THE INDUSTRIAL REVOLUTION, OTHER EUROPEAN COUNTRIES AND THE UNITED STATES SOON FOLLOWED. INDUSTRIALIZATION SPREAD UNEVENLY, INFLUENCED BY RESOURCE AVAILABILITY, POLITICAL STABILITY, AND CAPITAL INVESTMENT. JAPAN'S MEIJI RESTORATION REPRESENTS A NOTABLE CASE OF RAPID INDUSTRIAL ADOPTION OUTSIDE THE WEST, TRANSFORMING IT INTO A MAJOR INDUSTRIAL POWER BY THE EARLY 20TH CENTURY.

CHANGES IN LABOR AND PRODUCTION

THE RISE OF FACTORIES INTRODUCED NEW LABOR SYSTEMS CHARACTERIZED BY WAGE WORK, DIVISION OF LABOR, AND LONG WORKING HOURS. CHILD LABOR AND POOR WORKING CONDITIONS BECAME WIDESPREAD CONCERNS, PROMPTING EARLY LABOR MOVEMENTS AND CALLS FOR REFORM. THE FACTORY SYSTEM REPLACED ARTISANAL AND COTTAGE INDUSTRIES, CREATING A NEW INDUSTRIAL WORKFORCE.

SOCIAL AND ECONOMIC CHANGES

SOCIALISM AND COMMUNISM EMERGED AS CRITIQUES OF CAPITALIST SYSTEMS, PROPOSING ALTERNATIVE ECONOMIC MODELS FOCUSED ON COLLECTIVE OWNERSHIP AND SOCIAL WELFARE. THESE IDEOLOGIES INFLUENCED POLITICAL DISCOURSE AND REFORM MOVEMENTS GLOBALLY.

RESISTANCE AND REFORM IN COLONIZED REGIONS

COLONIZED PEOPLES RESPONDED TO IMPERIAL DOMINATION THROUGH RESISTANCE MOVEMENTS, REFORM EFFORTS, AND SELECTIVE ADOPTION OF WESTERN TECHNOLOGIES AND IDEAS. SOME SOCIETIES, LIKE THE OTTOMAN EMPIRE AND QING CHINA, ATTEMPTED MODERNIZATION PROGRAMS TO STRENGTHEN THEIR STATES AND RESIST FOREIGN CONTROL, THOUGH WITH MIXED RESULTS.

GLOBAL EXCHANGE OF IDEAS AND GOODS

THE PERIOD SAW INCREASED GLOBAL INTERCONNECTEDNESS THROUGH TRADE, MIGRATION, AND COMMUNICATION. IDEAS OF NATIONALISM, LIBERALISM, AND SOCIALISM SPREAD WIDELY, INFLUENCING POLITICAL DEVELOPMENTS WORLDWIDE. TECHNOLOGICAL INNOVATIONS FACILITATED FASTER TRANSPORT AND COMMUNICATION, SHRINKING DISTANCES AND INTEGRATING ECONOMIES.
