REHABILITATION AND RECOVERY PROCESS

EXPECTED RECOVERY TIMELINE

RECOVERY TIMELINES VARY DEPENDING ON INJURY SEVERITY AND INDIVIDUAL RESPONSE TO TREATMENT.
