THE DEPLETION OF B CELLS IS REVERSIBLE, ALLOWING THE IMMUNE SYSTEM TO RECOVER OVER TIME AFTER TREATMENT DISCONTINUATION. THIS MECHANISM IS SHARED WITH OTHER ANTI-CD20 THERAPIES BUT BRIUMVI DISTINGUISHES ITSELF THROUGH ITS DOSING REGIMEN AND ADMINISTRATION METHOD.

CLINICAL TRIAL RESULTS
