UNDERSTANDING PCOS AND METFORMIN

POLYCYSTIC OVARY SYNDROME (PCOS) IS A COMPLEX ENDOCRINE DISORDER THAT AFFECTS REPRODUCTIVE-AGED WOMEN. IF HAS GAINED ATTENTION FOR ITS POTENTIAL HEALTH BENEFITS, INCLUDING WEIGHT LOSS, IMPROVED INSULIN SENSITIVITY, REDUCED INFLAMMATION, AND BETTER METABOLIC HEALTH. THESE BENEFITS MAKE IT AN ATTRACTIVE OPTION FOR WOMEN WITH PCOS SEEKING TO IMPROVE THEIR CONDITION THROUGH LIFESTYLE MODIFICATIONS.

COMMON INTERMITTENT FASTING PROTOCOLS

- **16/8 METHOD:** FAST FOR 16 HOURS AND EAT DURING AN 8-HOUR WINDOW DAILY.
- **5:2 DIET:** EAT NORMALLY FIVE DAYS A WEEK AND LIMIT CALORIE INTAKE TO ABOUT 500-600 ON TWO NON-CONSECUTIVE DAYS.
- **ALTERNATE-DAY FASTING:** ALTERNATE BETWEEN FASTING DAYS AND NORMAL EATING DAYS.
- **EAT-STOP-EAT:** INVOLVES FASTING FOR 24 HOURS ONCE OR TWICE A WEEK.

INTERMITTENT FASTING AND METFORMIN: COMPATIBILITY AND CONSIDERATIONS

COMBINING INTERMITTENT FASTING WITH METFORMIN THERAPY RAISES IMPORTANT QUESTIONS ABOUT SAFETY, EFFECTIVENESS, AND POTENTIAL INTERACTIONS. POTENTIAL BENEFITS OF COMBINING INTERMITTENT FASTING WITH METFORMIN FOR PCOS

START GRADUALLY

BEGIN INTERMITTENT FASTING WITH SHORTER FASTING WINDOWS AND GRADUALLY INCREASE AS TOLERATED. THIS APPROACH ALLOWS THE BODY TO ADAPT AND MINIMIZES ADVERSE EFFECTS.

FOCUS ON NUTRIENT-DENSE FOODS

DURING EATING PERIODS, PRIORITIZE BALANCED MEALS RICH IN FIBER, LEAN PROTEINS, HEALTHY FATS, AND COMPLEX CARBOHYDRATES TO SUPPORT METABOLIC HEALTH AND SUSTAIN ENERGY LEVELS.

RECOGNIZE WARNING SIGNS

- DIZZINESS OR LIGHTEADEDNESS
- SEVERE FATIGUE OR WEAKNESS
- EXCESSIVE SWEATING OR SHAKINESS
- CONFUSION OR DIFFICULTY CONCENTRATING
- PERSISTENT GASTROINTESTINAL DISCOMFORT

IF ANY OF THESE SYMPTOMS OCCUR, IT IS IMPORTANT TO BREAK THE FAST AND SEEK MEDICAL ADVICE PROMPTLY.

FREQUENTLY ASKED QUESTIONS

CAN I DO INTERMITTENT FASTING WHILE TAKING METFORMIN FOR PCOS?
