BACKGROUND OF THE CAROLYN WARMUS CASE

THE CAROLYN WARMUS CASE REVOLVES AROUND THE 1989 MURDER OF BETTY JEANNE SOLOMON, A SCHOOLTEACHER IN NEW YORK.
