## OVERVIEW OF CHARLES COUNTY PUBLIC SCHOOLS LUNCH PROGRAM

THE CHARLES COUNTY PUBLIC SCHOOLS LUNCH PROGRAM IS DESIGNED TO PROVIDE STUDENTS WITH NUTRITIOUS AND APPEALING MEALS DURING THE SCHOOL DAY. THIS PROGRAM OPERATES IN ALL PUBLIC SCHOOLS WITHIN THE COUNTY, ENSURING THAT EVERY STUDENT HAS ACCESS TO A BALANCED LUNCH. THE DISTRICT COLLABORATES WITH NUTRITION EXPERTS AND FOOD SERVICE PROVIDERS TO DELIVER MEALS THAT ALIGN WITH USDA GUIDELINES. THE PROGRAM NOT ONLY SUPPORTS PHYSICAL HEALTH BUT ALSO ENHANCES COGNITIVE FUNCTION AND STUDENT ENGAGEMENT BY OFFERING FOODS THAT FUEL LEARNING. ADDITIONALLY, THE LUNCH SERVICE PROMOTES SOCIAL INTERACTION AMONG STUDENTS IN A SAFE AND WELCOMING ENVIRONMENT.

## MEAL COMPONENTS AND VARIETY

EACH CHARLES COUNTY PUBLIC SCHOOLS LUNCH INCLUDES MULTIPLE COMPONENTS TO CREATE A WELL-ROUNDED MEAL. TYPICAL OFFERINGS CONSIST OF A PROTEIN SOURCE, WHOLE GRAINS, FRUITS, VEGETABLES, AND MILK. MENUS ARE DESIGNED TO OFFER VARIETY THROUGHOUT THE WEEK, ROTATING SEASONAL PRODUCE AND DIFFERENT ENTR<sup>Y</sup> E OPTIONS TO MAINTAIN STUDENT INTEREST AND ACCOMMODATE PREFERENCES. THE INCLUSION OF DIVERSE CUISINES AND FLAVORS REFLECTS THE CULTURAL DIVERSITY OF THE STUDENT BODY, ENCOURAGING BROADER ACCEPTANCE AND ENJOYMENT OF HEALTHY FOODS.

## MEAL TIMES AND SERVING LOCATIONS

LUNCH PERIODS ARE SCHEDULED TO ALLOW SUFFICIENT TIME FOR STUDENTS TO EAT COMFORTABLY AND SOCIALIZE. MEALS ARE SERVED IN CAFETERIAS EQUIPPED WITH MODERN KITCHEN FACILITIES THAT MEET SAFETY AND HYGIENE STANDARDS. SOME SCHOOLS ALSO PROVIDE GRAB-AND-GO OPTIONS OR MOBILE CARTS TO ACCOMMODATE STUDENTS WITH LIMITED TIME OR THOSE INVOLVED IN EXTRACURRICULAR ACTIVITIES DURING LUNCH HOURS.

# NUTRITION STANDARDS AND MENU PLANNING

THE CHARLES COUNTY PUBLIC SCHOOLS LUNCH PROGRAM ADHERES STRICTLY TO FEDERAL NUTRITION STANDARDS ESTABLISHED BY THE HEALTHY, HUNGER-FREE KIDS ACT AND USDA REGULATIONS. THESE STANDARDS EMPHASIZE CALORIE LIMITS, SATURATED FAT RESTRICTIONS, AND SODIUM REDUCTION WHILE ENSURING ADEQUATE SERVINGS OF FRUITS, VEGETABLES, WHOLE GRAINS, AND LEAN PROTEINS. THE DISTRICT'S NUTRITION TEAM REGULARLY REVIEWS AND UPDATES MENUS TO MAINTAIN COMPLIANCE AND ADDRESS STUDENT FEEDBACK.

## FOCUS ON BALANCED NUTRITION

MENUS ARE CAREFULLY CRAFTED TO PROVIDE BALANCED NUTRITION THAT SUPPORTS GROWTH AND DEVELOPMENT. FOR EXAMPLE, MEALS INCLUDE AT LEAST TWO SERVINGS OF VEGETABLES AND FRUITS DAILY, WITH AN EMPHASIS ON DARK GREEN, RED/ORANGE, AND LEGUMES. WHOLE GRAIN-RICH FOODS ARE INCORPORATED IN BREAD, PASTA, AND RICE OPTIONS. LEAN PROTEINS SUCH AS POULTRY, FISH, BEANS, AND LOW-FAT DAIRY PRODUCTS HELP MEET PROTEIN REQUIREMENTS WITHOUT EXCESSIVE SATURATED FAT.

## INCORPORATION OF LOCALLY SOURCED INGREDIENTS

TO PROMOTE FRESHNESS AND SUSTAINABILITY, CHARLES COUNTY PUBLIC SCHOOLS LUNCH PROGRAMS OFTEN INCORPORATE LOCALLY SOURCED INGREDIENTS. PARTNERSHIPS WITH LOCAL FARMERS AND SUPPLIERS HELP ENSURE THAT PRODUCE AND OTHER FOOD ITEMS ARE FRESH AND SEASONAL. THIS APPROACH SUPPORTS THE LOCAL ECONOMY AND EDUCATES STUDENTS ABOUT THE BENEFITS OF FARM-TO-SCHOOL INITIATIVES.

## MEAL ACCESSIBILITY AND PAYMENT OPTIONS

ACCESSIBILITY TO CHARLES COUNTY PUBLIC SCHOOLS LUNCH IS A PRIORITY, WITH MULTIPLE PAYMENT OPTIONS AVAILABLE TO ACCOMMODATE FAMILIES' NEEDS. ## PAYMENT METHODS

FAMILIES CAN PAY FOR LUNCHESES THROUGH AN ONLINE PORTAL, WHICH PROVIDES SECURE AND EASY MANAGEMENT OF MEAL ACCOUNTS. ADDITIONALLY, CASH AND CHECKS ARE ACCEPTED AT SCHOOL CAFETERIAS. PREPAYMENT IS ENCOURAGED TO MINIMIZE TRANSACTION TIMES DURING LUNCH PERIODS AND TO ENSURE STUDENTS CAN RECEIVE MEALS WITHOUT INTERRUPTION.

## MEAL PRICING STRUCTURE

THE LUNCH PROGRAM OFFERS COMPETITIVE PRICING THAT REFLECTS THE QUALITY AND NUTRITIONAL VALUE OF THE MEALS SERVED. PRICING IS SET ANNUALLY, WITH STANDARD RATES FOR PAID LUNCHESES AND DISCOUNTED RATES FOR ELIGIBLE STUDENTS. THE DISTRICT ALSO PROVIDES TRANSPARENCY REGARDING MEAL COSTS, ALLOWING FAMILIES TO BUDGET ACCORDINGLY.

## FREE AND REDUCED-PRICE MEAL ELIGIBILITY

CHARLES COUNTY PUBLIC SCHOOLS LUNCH PROGRAM INCLUDES PROVISIONS FOR FREE AND REDUCED-PRICE MEALS TO SUPPORT STUDENTS FROM LOW-INCOME HOUSEHOLDS. THESE OPTIONS ENSURE THAT ALL STUDENTS HAVE EQUITABLE ACCESS TO NUTRITIOUS MEALS, REGARDLESS OF FINANCIAL STATUS. THE APPLICATION PROCESS FOR THESE BENEFITS IS STRAIGHTFORWARD AND CONFIDENTIAL.

## ELIGIBILITY CRITERIA

ELIGIBILITY FOR FREE OR REDUCED-PRICE MEALS IS DETERMINED BASED ON FEDERAL INCOME GUIDELINES AND HOUSEHOLD SIZE. FAMILIES MUST SUBMIT AN APPLICATION TO THE SCHOOL DISTRICT, WHICH REVIEWS AND VERIFIES THE INFORMATION TO GRANT BENEFITS. STUDENTS WHO QUALIFY RECEIVE MEALS AT NO COST OR A SIGNIFICANTLY REDUCED PRICE, HELPING TO ALLEVIATE FOOD INSECURITY.

## DIRECT CERTIFICATION AND AUTOMATIC ELIGIBILITY

IN ADDITION TO APPLICATION-BASED ELIGIBILITY, THE DISTRICT PARTICIPATES IN DIRECT CERTIFICATION PROGRAMS THAT AUTOMATICALLY QUALIFY STUDENTS RECEIVING ASSISTANCE FROM OTHER GOVERNMENT PROGRAMS SUCH AS SNAP OR TANF. THIS EFFICIENT SYSTEM REDUCES PAPERWORK AND ENSURES TIMELY ACCESS TO MEAL BENEFITS.

## SPECIAL DIETARY ACCOMMODATIONS
