EFFECTIVE COMMUNICATION BETWEEN STUDENTS, PARENTS, TEACHERS, AND ADMINISTRATORS IS VITAL. ESTABLISHING CLEAR REPORTING MECHANISMS AND FOSTERING TRUST CAN HELP ADDRESS CONCERNS BEFORE THEY ESCALATE.

IMPLEMENTING COMPREHENSIVE SAFETY PLANS

SCHOOLS ARE URGED TO DEVELOP AND REGULARLY UPDATE COMPREHENSIVE SAFETY PLANS THAT INCLUDE PREVENTION, RESPONSE, AND RECOVERY STRATEGIES. COLLABORATION WITH LAW ENFORCEMENT AND MENTAL HEALTH PROFESSIONALS ENHANCES THESE EFFORTS.
