RAILROADS AND THEIR ECONOMIC SIGNIFICANCE

THE INTRODUCTION AND RAPID EXPANSION OF RAILROADS DURING THE MARKET REVOLUTION FURTHER ACCELERATED ECONOMIC INTEGRATION. RAILROADS PROVIDED FASTER AND MORE RELIABLE TRANSPORT THAN CANALS OR ROADS, LINKING DISTANT MARKETS AND FOSTERING REGIONAL SPECIALIZATION.

SOCIAL CHANGES AND LABOR TRANSFORMATIONS
