UNDERSTANDING EDFINANCIAL REFUNDS

WHAT IS AN EDFINANCIAL REFUND?

WHO IS ELIGIBLE FOR AN EDFINANCIAL REFUND?

ELIGIBILITY FOR AN EDFINANCIAL REFUND DEPENDS ON THE BORROWER'S ACCOUNT STATUS AND PAYMENT HISTORY. BORROWERS WHO HAVE MADE EXCESS PAYMENTS, RECEIVED LOAN DISBURSEMENTS THAT WERE LATER CANCELED, OR HAD THEIR LOANS ADJUSTED DUE TO ELIGIBILITY CHANGES MAY QUALIFY FOR A REFUND. ADDITIONALLY, REFUNDS CAN BE ISSUED TO BORROWERS WHO HAVE CONSOLIDATED LOANS OR PARTICIPATED IN REPAYMENT PLANS THAT AFFECT THE LOAN BALANCE. IT IS IMPORTANT FOR BORROWERS TO REVIEW THEIR ACCOUNT STATEMENTS REGULARLY TO IDENTIFY POSSIBLE REFUND OPPORTUNITIES.

COMMON REASONS FOR EdFINANCIAL REFUNDS

LOAN DISBURSEMENT CANCELLATION

LOAN ADJUSTMENTS AND CORRECTIONS

SOMETIMES, LOAN SERVICERS MUST ADJUST LOAN BALANCES DUE TO ERRORS OR CHANGES IN BORROWER STATUS, SUCH AS DEFERMENT OR FORBEARANCE APPROVALS, INTEREST RATE CORRECTIONS, OR LOAN FORGIVENESS PROGRAMS. THESE ADJUSTMENTS MAY RESULT IN A REFUND IF THE BORROWER'S ACCOUNT BALANCE IS REDUCED AFTER PAYMENTS HAVE BEEN APPLIED.

LOAN CONSOLIDATION AND REPAYMENT PLAN CHANGES

WHEN BORROWERS CONSOLIDATE THEIR LOANS OR SWITCH REPAYMENT PLANS, PREVIOUS PAYMENTS MAY BE RECALCULATED, LEADING TO POTENTIAL REFUNDS. THESE FINANCIAL CHANGES CAN ALTER THE LOAN PAYOFF SCHEDULE AND BALANCE, SOMETIMES GENERATING CREDIT REFUNDS TO BORROWERS.
