THE GRANT SUPPORTS PROJECTS THAT DEMONSTRATE POTENTIAL FOR JOB CREATION, TECHNOLOGICAL INNOVATION, AND ECONOMIC DIVERSIFICATION. IT IS ADMINISTERED BY THE DELAWARE DIVISION OF SMALL BUSINESS, WHICH COLLABORATES WITH LOCAL ECONOMIC DEVELOPMENT AGENCIES TO IDENTIFY PROMISING CANDIDATES.

EDGE GRANT DELAWARE IS TAILORED TO SUPPORT A WIDE VARIETY OF SECTORS INCLUDING TECHNOLOGY, MANUFACTURING, LIFE SCIENCES, AND CLEAN ENERGY. THE PROGRAM AIMS TO REDUCE FINANCIAL BARRIERS FOR COMPANIES UNDERTAKING EXPANSION, RESEARCH AND DEVELOPMENT, OR WORKFORCE TRAINING INITIATIVES. BY OFFERING THIS GRANT, DELAWARE SEEKS TO ATTRACT NEW BUSINESSES WHILE RETAINING AND EXPANDING EXISTING ENTERPRISES, ULTIMATELY STRENGTHENING THE STATE'S ECONOMIC INFRASTRUCTURE.

ELIGIBILITY AND QUALIFICATION CRITERIA

TO QUALIFY FOR THE EDGE GRANT DELAWARE PROGRAM, APPLICANTS MUST MEET SPECIFIC ELIGIBILITY REQUIREMENTS SET FORTH BY THE ADMINISTERING AGENCY. THESE CRITERIA ENSURE THAT THE GRANT FUNDS ARE DIRECTED TOWARD PROJECTS WITH MEASURABLE ECONOMIC IMPACT AND COMMUNITY BENEFIT. ELIGIBLE APPLICANTS TYPICALLY INCLUDE SMALL TO MEDIUM-SIZED ENTERPRISES (SMEs), STARTUPS, AND SOMETIMES NONPROFIT ORGANIZATIONS ENGAGED IN ECONOMIC DEVELOPMENT ACTIVITIES.

BUSINESS REQUIREMENTS

APPLICANTS MUST GENERALLY DEMONSTRATE THAT THEIR BUSINESS IS LEGALLY REGISTERED IN DELAWARE AND OPERATES WITHIN AN INDUSTRY ALIGNED WITH THE STATE'S ECONOMIC PRIORITIES. THE BUSINESS SHOULD DISPLAY A CLEAR GROWTH TRAJECTORY OR POTENTIAL FOR JOB CREATION AND INNOVATION.

PROJECT CRITERIA

THE PROPOSED PROJECT MUST OUTLINE HOW THE EDGE GRANT FUNDS WILL BE UTILIZED TO ACHIEVE SPECIFIC OBJECTIVES SUCH AS:

- EXPANDING PRODUCTION CAPACITY
- DEVELOPING NEW PRODUCTS OR SERVICES
- IMPLEMENTING WORKFORCE TRAINING PROGRAMS
- ADOPTING ADVANCED TECHNOLOGY OR EQUIPMENT
- IMPROVING SUSTAINABILITY AND ENERGY EFFICIENCY

FINANCIAL AND REPORTING REQUIREMENTS

APPLICANTS ARE REQUIRED TO PROVIDE DETAILED FINANCIAL STATEMENTS, BUDGETS, AND PROJECTIONS TO JUSTIFY THE GRANT REQUEST. POST-AWARD, RECIPIENTS MUST SUBMIT REGULAR PROGRESS REPORTS TO DEMONSTRATE COMPLIANCE AND EFFECTIVENESS OF THE FUNDED INITIATIVES.

APPLICATION PROCESS AND REQUIREMENTS

THE APPLICATION PROCESS FOR THE EDGE GRANT DELAWARE INVOLVES SEVERAL STRUCTURED STEPS TO ENSURE TRANSPARENCY AND MERIT-BASED SELECTION. SUBMISSION GUIDELINES

THE FORMAL APPLICATION INCLUDES DETAILED NARRATIVES DESCRIBING THE PROJECT SCOPE, EXPECTED OUTCOMES, AND BUDGET. APPLICANTS MUST COMPLETE ALL REQUIRED FORMS PROVIDED BY THE DELAWARE DIVISION OF SMALL BUSINESS AND SUBMIT THEM BY THE DESIGNATED DEADLINE.

REVIEW AND SELECTION

BENEFITS AND IMPACT OF THE EDGE GRANT

THE EDGE GRANT DELAWARE OFFERS MULTIPLE BENEFITS THAT CONTRIBUTE SIGNIFICANTLY TO THE ECONOMIC VITALITY OF THE STATE. 3. **STRONG ECONOMIC JUSTIFICATION:** EMPHASIZE HOW THE PROJECT WILL CREATE JOBS, FOSTER INNOVATION, AND CONTRIBUTE TO DELAWARE'S ECONOMY.
4. **ACCURATE AND COMPLETE DOCUMENTATION:** PROVIDE ALL REQUIRED FINANCIAL AND LEGAL DOCUMENTS, ENSURING ACCURACY AND TIMELINESS.
5. **PROFESSIONAL PRESENTATION:** PRESENT THE APPLICATION IN A CLEAR, CONCISE, AND PROFESSIONAL MANNER THAT HIGHLIGHTS THE PROJECT'S STRENGTHS.
6. **FOLLOW-UP AND COMMUNICATION:** MAINTAIN OPEN COMMUNICATION WITH THE GRANT ADMINISTRATORS AND PROMPTLY RESPOND TO ANY REQUESTS FOR ADDITIONAL INFORMATION.

FREQUENTLY ASKED QUESTIONS

WHAT IS THE EDGE GRANT PROGRAM IN DELAWARE?

WHAT TYPES OF PROJECTS QUALIFY FOR THE DELAWARE EDGE GRANT?

PROJECTS THAT INVOLVE BUSINESS EXPANSION, RELOCATION TO DELAWARE, JOB CREATION, AND CAPITAL INVESTMENT GENERALLY QUALIFY FOR THE DELAWARE EDGE GRANT, ESPECIALLY THOSE THAT HAVE A POSITIVE IMPACT ON THE STATE'S ECONOMY.

HOW CAN A BUSINESS APPLY FOR THE DELAWARE EDGE GRANT?

BUSINESSES CAN APPLY FOR THE DELAWARE EDGE GRANT BY SUBMITTING AN APPLICATION THROUGH THE DELAWARE ECONOMIC DEVELOPMENT OFFICE OR THE DELAWARE DIVISION OF SMALL BUSINESS, DETAILING THEIR PROJECT PLANS, JOB CREATION ESTIMATES, AND INVESTMENT COMMITMENTS.

ARE THERE ANY REPORTING REQUIREMENTS AFTER RECEIVING THE DELAWARE EDGE GRANT?

YES, RECIPIENTS OF THE DELAWARE EDGE GRANT ARE USUALLY REQUIRED TO PROVIDE REGULAR REPORTS VERIFYING JOB CREATION, INVESTMENT MILESTONES, AND COMPLIANCE WITH THE GRANT TERMS FOR A SPECIFIED PERIOD.

IS THE DELAWARE EDGE GRANT AVAILABLE TO STARTUPS OR ONLY ESTABLISHED COMPANIES?

WHILE THE EDGE GRANT PRIMARILY TARGETS BUSINESSES EXPANDING OR RELOCATING WITH SIGNIFICANT JOB CREATION, SOME PROGRAMS MAY ALSO SUPPORT STARTUPS IF THEY MEET THE ELIGIBILITY CRITERIA RELATED TO JOB CREATION AND INVESTMENT.
