UNDERSTANDING POSITIONALITY STATEMENTS

A POSITIONALITY STATEMENT IS A REFLECTIVE DECLARATION IN WHICH RESEARCHERS OR PROFESSIONALS EXPLICITLY IDENTIFY THEIR SOCIAL, CULTURAL, AND PERSONAL PERSPECTIVES THAT INFLUENCE THEIR APPROACH TO A STUDY OR PROJECT. IT ACKNOWLEDGES THAT COMPLETE OBJECTIVITY IS CHALLENGING AND THAT ONE'S BACKGROUND CAN SHAPE INTERPRETATIONS AND INTERACTIONS. THIS STATEMENT OFTEN INCLUDES INFORMATION ABOUT THE AUTHOR'S IDENTITY, EXPERIENCES, AND POTENTIAL BIASES. BY ARTICULATING POSITIONALITY, INDIVIDUALS ENHANCE THE TRANSPARENCY OF THEIR WORK AND ALLOW AUDIENCES TO CRITICALLY ENGAGE WITH THE FINDINGS. THE CONCEPT IS WIDELY USED IN QUALITATIVE RESEARCH, SOCIAL SCIENCES, EDUCATION, AND HUMANITIES.

DEFINITION AND PURPOSE

AT ITS CORE, A POSITIONALITY STATEMENT IS A CONCISE ACCOUNT OF WHO THE RESEARCHER IS IN RELATION TO THE TOPIC UNDER INVESTIGATION. IT SERVES TO DISCLOSE THE LENS THROUGH WHICH DATA IS GATHERED, ANALYZED, AND PRESENTED. THE PURPOSE OF THIS DISCLOSURE IS TWOFOLD: TO ACKNOWLEDGE THE RESEARCHER'S INFLUENCE ON THE STUDY AND TO PROMOTE REFLEXIVITY, WHICH IS THE PRACTICE OF CONTINUOUSLY EXAMINING ONE'S ASSUMPTIONS AND IMPACT ON THE RESEARCH PROCESS. THIS HELPS FOSTER TRUSTWORTHINESS AND RIGOR IN ACADEMIC AND PROFESSIONAL WORK.

CONTEXTS OF USAGE

POSITIONALITY STATEMENTS ARE MOST PREVALENT IN QUALITATIVE RESEARCH METHODOLOGIES SUCH AS ETHNOGRAPHY, CASE STUDIES, AND PHENOMENOLOGY, WHERE RESEARCHER-SUBJECT INTERACTION IS SIGNIFICANT. HOWEVER, THEY ARE ALSO VALUABLE IN FIELDS LIKE EDUCATION, HEALTHCARE, AND SOCIAL WORK, WHERE UNDERSTANDING ONE'S POSITIONALITY CAN AFFECT PRACTICE AND POLICY RECOMMENDATIONS. IN ADDITION, MANY ACADEMIC JOURNALS AND INSTITUTIONS NOW ENCOURAGE OR REQUIRE POSITIONALITY STATEMENTS TO ACCOMPANY RESEARCH MANUSCRIPTS.

IMPORTANCE OF POSITIONALITY IN RESEARCH

RECOGNIZING AND ARTICULATING POSITIONALITY IS CRUCIAL FOR MAINTAINING ETHICAL STANDARDS AND ENSURING RESEARCH INTEGRITY. IT HELPS TO IDENTIFY POTENTIAL BIASES THAT MAY INFLUENCE DATA COLLECTION, ANALYSIS, AND INTERPRETATION. MOREOVER, POSITIONALITY STATEMENTS CONTRIBUTE TO THE BROADER DISCOURSE BY SITUATING RESEARCH WITHIN SOCIAL AND CULTURAL CONTEXTS, ALLOWING READERS TO CRITICALLY ASSESS THE STUDY'S VALIDITY AND APPLICABILITY.

ENHANCING CREDIBILITY AND TRANSPARENCY

BY DECLARING POSITIONALITY, RESEARCHERS PROVIDE READERS WITH A FRAMEWORK TO UNDERSTAND HOW PERSONAL EXPERIENCES AND WORLDVIEWS MIGHT AFFECT THE RESEARCH PROCESS. THIS TRANSPARENCY BUILDS CREDIBILITY, DEMONSTRATING THAT THE RESEARCHER HAS CRITICALLY REFLECTED ON THEIR ROLE AND INFLUENCE. IT ALSO MITIGATES CONCERNS ABOUT HIDDEN BIASES THAT COULD COMPROMISE THE FINDINGS.

FACILITATING REFLEXIVITY

POSITIONALITY STATEMENTS ENCOURAGE REFLEXIVITY, WHICH INVOLVES ONGOING SELF-AWARENESS AND EVALUATION THROUGHOUT THE RESEARCH JOURNEY. REFLEXIVITY HELPS RESEARCHERS REMAIN CONSCIOUS OF THEIR IMPACT ON PARTICIPANTS AND DATA INTERPRETATION, LEADING TO MORE NUANCED AND BALANCED OUTCOMES. THIS PROCESS ULTIMATELY STRENGTHENS THE QUALITY AND DEPTH OF THE RESEARCH.

KEY COMPONENTS OF A POSITIONALITY STATEMENT

AN EFFECTIVE POSITIONALITY STATEMENT TYPICALLY INCLUDES SEVERAL ESSENTIAL ELEMENTS THAT TOGETHER PROVIDE A COMPREHENSIVE VIEW OF THE AUTHOR'S STANDPOINT. THESE COMPONENTS ENABLE THE READER TO GRASP THE FACTORS THAT MAY INFLUENCE THE RESEARCH OR PROFESSIONAL PERSPECTIVE.

PERSONAL AND SOCIAL IDENTITY

THIS ELEMENT COVERS ASPECTS SUCH AS RACE, ETHNICITY, GENDER, SOCIOECONOMIC STATUS, NATIONALITY, AND OTHER IDENTITY MARKERS. THESE FACTORS SHAPE HOW INDIVIDUALS EXPERIENCE THE WORLD AND INTERACT WITH THEIR RESEARCH OR PROFESSIONAL ENVIRONMENT. INCLUDING THIS INFORMATION HELPS CONTEXTUALIZE THE AUTHOR'S PERSPECTIVE.

PROFESSIONAL BACKGROUND AND EXPERIENCE

DETAILS ABOUT ACADEMIC TRAINING, CAREER HISTORY, AND RELEVANT EXPERIENCES ARE INTEGRAL TO UNDERSTANDING HOW THE AUTHOR APPROACHES THEIR WORK. THIS COMPONENT HIGHLIGHTS EXPERTISE AS WELL AS POTENTIAL BIASES STEMMING FROM PREVIOUS ROLES OR AFFILIATIONS.

RELATIONSHIP TO THE RESEARCH TOPIC

CLARIFYING ANY PERSONAL CONNECTION OR VESTED INTEREST IN THE RESEARCH TOPIC IS IMPORTANT. THIS COULD INVOLVE LIVED EXPERIENCE, PRIOR INVOLVEMENT, OR PARTICULAR VIEWPOINTS THAT MIGHT INFLUENCE DATA INTERPRETATION. TRANSPARENCY ABOUT THESE RELATIONSHIPS STRENGTHENS ETHICAL STANDARDS.

POTENTIAL BIASES AND ASSUMPTIONS

IDENTIFYING PRECONCEIVED NOTIONS OR PERSPECTIVES THAT COULD AFFECT THE STUDY ENCOURAGES OPENNESS AND CRITICAL

SELF-REFLECTION. ACKNOWLEDGING THESE BIASES ALLOWS READERS TO INTERPRET FINDINGS WITH AN INFORMED LENS.

EXAMPLE OF POSITIONALITY STATEMENT IN DIFFERENT CONTEXTS

POSITIONALITY STATEMENTS VARY DEPENDING ON THE DISCIPLINE AND PURPOSE OF THE RESEARCH OR PROJECT. BELOW ARE SEVERAL EXAMPLES ILLUSTRATING HOW TO EFFECTIVELY CRAFT THESE STATEMENTS ACROSS DIFFERENT FIELDS.

EXAMPLE IN QUALITATIVE SOCIAL SCIENCE RESEARCH

"AS A MIDDLE-CLASS, WHITE FEMALE RESEARCHER WITH A BACKGROUND IN SOCIOLOGY, I ACKNOWLEDGE THAT MY EXPERIENCES MAY INFLUENCE MY INTERPRETATION OF PARTICIPANTS' NARRATIVES. MY ACADEMIC TRAINING EMPHASIZES SOCIAL JUSTICE, WHICH INFORMS MY COMMITMENT TO ETHICAL REPRESENTATION OF MARGINALIZED VOICES. I RECOGNIZE THAT MY POSITIONALITY SHAPES THE QUESTIONS I POSE AND THE THEMES I PRIORITIZE IN DATA ANALYSIS."

EXAMPLE IN EDUCATION RESEARCH

"COMING FROM A BILINGUAL, IMMIGRANT HOUSEHOLD AND WORKING AS AN EDUCATOR IN URBAN SCHOOLS, I BRING A PERSONAL UNDERSTANDING OF THE CHALLENGES FACED BY ENGLISH LANGUAGE LEARNERS. MY POSITIONALITY AS BOTH AN INSIDER AND A RESEARCHER INFLUENCES MY APPROACH TO STUDYING LANGUAGE ACQUISITION AND EDUCATIONAL EQUITY. I REMAIN VIGILANT ABOUT HOW MY ASSUMPTIONS MIGHT SHAPE INTERACTIONS WITH PARTICIPANTS."

EXAMPLE IN HEALTHCARE RESEARCH

"AS A HEALTHCARE PROFESSIONAL WITH CLINICAL EXPERIENCE IN MENTAL HEALTH SERVICES, I ACKNOWLEDGE THAT MY PROFESSIONAL BACKGROUND INFORMS MY PERSPECTIVE ON PATIENT CARE. MY POSITIONALITY INCLUDES AWARENESS OF SYSTEMIC DISPARITIES IN HEALTHCARE ACCESS, WHICH MOTIVATES MY FOCUS ON INCLUSIVE PRACTICES. I STRIVE TO BALANCE EMPATHY WITH CRITICAL ANALYSIS IN INTERPRETING QUALITATIVE DATA."

EXAMPLE IN ENVIRONMENTAL STUDIES

"RAISED IN A RURAL COMMUNITY DEPENDENT ON AGRICULTURE, I HAVE FIRSTHAND KNOWLEDGE OF ENVIRONMENTAL CHALLENGES RELATED TO LAND USE. MY POSITIONALITY AS BOTH A LOCAL RESIDENT AND ENVIRONMENTAL SCIENTIST INFLUENCES MY RESEARCH PRIORITIES AND INTERPRETATION OF COMMUNITY-BASED DATA. I AM CONSCIOUS OF POTENTIAL BIASES STEMMING FROM PERSONAL ATTACHMENT TO THE REGION."

HOW TO WRITE AN EFFECTIVE POSITIONALITY STATEMENT

WRITING A POSITIONALITY STATEMENT REQUIRES THOUGHTFUL REFLECTION AND CLARITY. THE FOLLOWING GUIDELINES ASSIST IN CRAFTING A STATEMENT THAT IS HONEST, CONCISE, AND RELEVANT TO THE RESEARCH OR PROFESSIONAL CONTEXT.

STEP-BY-STEP APPROACH

1. **REFLECT ON IDENTITY:** CONSIDER ASPECTS OF YOUR PERSONAL AND SOCIAL IDENTITY THAT RELATE TO THE TOPIC.
2. **ASSESS PROFESSIONAL BACKGROUND:** IDENTIFY HOW YOUR ACADEMIC AND CAREER EXPERIENCES INFLUENCE YOUR PERSPECTIVE.

3. **EVALUATE RELATIONSHIP TO TOPIC:** DETERMINE ANY PERSONAL OR PROFESSIONAL CONNECTIONS TO THE SUBJECT MATTER.
4. **RECOGNIZE POTENTIAL BIASES:** ACKNOWLEDGE ASSUMPTIONS AND VIEWPOINTS THAT MAY IMPACT YOUR WORK.
5. **WRITE CLEARLY AND CONCISELY:** USE STRAIGHTFORWARD LANGUAGE TO COMMUNICATE YOUR POSITIONALITY EFFECTIVELY.

BEST PRACTICES

- MAINTAIN HONESTY AND TRANSPARENCY WITHOUT OVER-DISCLOSURE.
- TAILOR THE STATEMENT TO THE SPECIFIC RESEARCH OR PROFESSIONAL CONTEXT.
- KEEP THE STATEMENT CONCISE, TYPICALLY BETWEEN 150 TO 300 WORDS.
- USE REFLECTIVE AND CRITICAL LANGUAGE TO DEMONSTRATE AWARENESS.
- UPDATE THE STATEMENT AS NECESSARY TO REFLECT EVOLVING PERSPECTIVES.

FREQUENTLY ASKED QUESTIONS

WHAT IS A POSITIONALITY STATEMENT?

A POSITIONALITY STATEMENT IS A REFLECTIVE PIECE WHERE RESEARCHERS ACKNOWLEDGE THEIR OWN BACKGROUND, PERSPECTIVES, AND POTENTIAL BIASES THAT MAY INFLUENCE THEIR RESEARCH.

CAN YOU PROVIDE A SIMPLE EXAMPLE OF A POSITIONALITY STATEMENT?

YES. FOR EXAMPLE: "AS A MIDDLE-CLASS, WHITE FEMALE RESEARCHER FROM AN URBAN BACKGROUND, I RECOGNIZE THAT MY EXPERIENCES MAY SHAPE HOW I INTERPRET DATA RELATED TO RURAL COMMUNITIES."

WHY IS INCLUDING A POSITIONALITY STATEMENT IMPORTANT IN RESEARCH?

INCLUDING A POSITIONALITY STATEMENT PROMOTES TRANSPARENCY BY REVEALING HOW THE RESEARCHER'S BACKGROUND AND PERSPECTIVES MIGHT AFFECT THEIR APPROACH AND INTERPRETATION OF DATA.

WHAT SHOULD BE INCLUDED IN A POSITIONALITY STATEMENT?

A POSITIONALITY STATEMENT SHOULD INCLUDE THE RESEARCHER'S SOCIAL IDENTITIES (SUCH AS RACE, GENDER, CLASS), EXPERIENCES, VALUES, AND HOW THESE MIGHT INFLUENCE THE RESEARCH PROCESS.

HOW DOES A POSITIONALITY STATEMENT DIFFER FROM A BIAS STATEMENT?

A POSITIONALITY STATEMENT IS BROADER, ENCOMPASSING THE RESEARCHER'S OVERALL BACKGROUND AND PERSPECTIVE, WHILE A BIAS STATEMENT SPECIFICALLY ADDRESSES POTENTIAL PREJUDICES OR PRECONCEPTIONS THAT COULD AFFECT THE RESEARCH.

COULD YOU GIVE AN EXAMPLE OF A POSITIONALITY STATEMENT FOR A QUALITATIVE STUDY?

CERTAINLY. "AS A FIRST-GENERATION COLLEGE STUDENT AND LATINA RESEARCHER, MY LIVED EXPERIENCES INFLUENCE MY UNDERSTANDING AND INTERPRETATION OF PARTICIPANTS' NARRATIVES IN THIS QUALITATIVE STUDY."

IS A POSITIONALITY STATEMENT ONLY RELEVANT IN QUALITATIVE RESEARCH?

WHILE IT IS MOST COMMONLY USED IN QUALITATIVE RESEARCH TO ACKNOWLEDGE SUBJECTIVITY, POSITIONALITY STATEMENTS CAN ALSO BE VALUABLE IN QUANTITATIVE STUDIES TO PROVIDE CONTEXT ABOUT THE RESEARCHER'S PERSPECTIVE.
