UNDERSTANDING FAMILY HISTORY IN COLON CANCER

RELEVANT ICD-10 CODES

THE PRIMARY ICD-10 CODE USED TO DOCUMENT A FAMILY HISTORY OF COLON CANCER IS:

- **Z80.0** - FAMILY HISTORY OF MALIGNANT NEOPLASM OF DIGESTIVE ORGANS

THIS CODE IS USED WHEN THERE IS A DOCUMENTED FAMILY HISTORY OF COLON CANCER OR OTHER DIGESTIVE SYSTEM CANCERS. ADDITIONAL CODES EXIST FOR FAMILY HISTORIES OF OTHER SPECIFIC CANCERS, BUT Z80.0 IS THE MOST RELEVANT FOR COLON CANCER.

PROPER USAGE AND DOCUMENTATION

HEALTHCARE PROVIDERS MUST ENSURE THAT THE PATIENT'S MEDICAL RECORD CLEARLY INDICATES THE PRESENCE OF A FAMILY HISTORY OF COLON CANCER BEFORE ASSIGNING THE Z80.0 CODE. THIS INVOLVES THOROUGH PATIENT INTERVIEWS AND REVIEW OF FAMILY MEDICAL HISTORIES. ACCURATE CODING SUPPORTS RISK STRATIFICATION AND GUIDES CLINICAL MANAGEMENT DECISIONS.

CLINICAL IMPORTANCE OF DOCUMENTING FAMILY HISTORY
