FCPS ESY REFERS TO THE EXTENDED SCHOOL YEAR (ESY) SERVICES PROVIDED BY FAIRFAX COUNTY PUBLIC SCHOOLS (FCPS). THESE SPECIALIZED EDUCATIONAL SERVICES ARE DESIGNED TO SUPPORT STUDENTS WITH DISABILITIES WHO REQUIRE ADDITIONAL INSTRUCTIONAL TIME BEYOND THE TRADITIONAL SCHOOL YEAR TO PREVENT SIGNIFICANT REGRESSION OF SKILLS. FCPS ESY PROGRAMS ENSURE CONTINUITY IN LEARNING AND ADDRESS SPECIFIC NEEDS BASED ON INDIVIDUALIZED EDUCATION PROGRAMS (IEPs). UNDERSTANDING THE ELIGIBILITY CRITERIA, PROGRAM STRUCTURE, AND BENEFITS OF FCPS ESY IS ESSENTIAL FOR PARENTS, EDUCATORS, AND STAKEHOLDERS. THIS ARTICLE EXPLORES THE COMPREHENSIVE FRAMEWORK OF FCPS ESY, INCLUDING HOW STUDENTS QUALIFY, THE TYPES OF SERVICES OFFERED, AND THE PROCEDURES FOR ENROLLMENT. UNDERSTANDING FCPS ESY

FCPS ESY STANDS FOR FAIRFAX COUNTY PUBLIC SCHOOLS EXTENDED SCHOOL YEAR SERVICES, WHICH ARE TAILORED EDUCATIONAL PROGRAMS DESIGNED TO MEET THE UNIQUE NEEDS OF STUDENTS WITH DISABILITIES. THESE SERVICES ARE PROVIDED BEYOND THE REGULAR ACADEMIC CALENDAR TO HELP MAINTAIN AND ENHANCE THE SKILLS ACQUIRED DURING THE SCHOOL YEAR. THE ESY PROGRAM IS GROUNDED IN FEDERAL REGULATIONS UNDER THE INDIVIDUALS WITH DISABILITIES EDUCATION ACT (IDEA), ENSURING THAT ELIGIBLE STUDENTS RECEIVE APPROPRIATE SUPPORT TO PREVENT SUBSTANTIAL REGRESSION OR LOSS OF PREVIOUSLY MASTERED SKILLS.

PURPOSE OF FCPS ESY

THE PRIMARY PURPOSE OF FCPS ESY IS TO PROVIDE CONTINUOUS LEARNING OPPORTUNITIES FOR STUDENTS WHO DEMONSTRATE A NEED FOR ADDITIONAL INSTRUCTION DURING THE SUMMER OR OTHER EXTENDED PERIODS. THIS PREVENTS SKILL REGRESSION, PARTICULARLY IN CRITICAL ACADEMIC, FUNCTIONAL, OR BEHAVIORAL AREAS, ENSURING THAT STUDENTS REMAIN ON TRACK WITH THEIR INDIVIDUALIZED EDUCATION PROGRAM (IEP) GOALS.

LEGAL FOUNDATION

FCPS ESY PROGRAMS ADHERE TO IDEA MANDATES, WHICH REQUIRE PUBLIC SCHOOLS TO PROVIDE FREE APPROPRIATE PUBLIC EDUCATION (FAPE) TO STUDENTS WITH DISABILITIES, INCLUDING EXTENDED SERVICES WHEN NECESSARY. ESY SERVICES ARE NOT DESIGNED TO ACCELERATE LEARNING BUT TO MAINTAIN ESSENTIAL SKILLS THAT MIGHT OTHERWISE DETERIORATE OVER EXTENDED BREAKS FROM SCHOOL.

ELIGIBILITY CRITERIA FOR FCPS ESY

DETERMINING ELIGIBILITY FOR FCPS ESY INVOLVES A THOROUGH EVALUATION OF EACH STUDENT'S EDUCATIONAL NEEDS. NOT ALL STUDENTS WITH DISABILITIES AUTOMATICALLY QUALIFY; ELIGIBILITY IS BASED ON INDIVIDUAL ASSESSMENT AND DOCUMENTED EVIDENCE OF POTENTIAL REGRESSION WITHOUT EXTENDED SERVICES.

EVALUATION PROCESS

ELIGIBILITY IS ASSESSED THROUGH A COMPREHENSIVE REVIEW OF A STUDENT'S PROGRESS, REGRESSION PATTERNS, AND OVERALL EDUCATIONAL REQUIREMENTS. THE IEP TEAM—including educators, specialists, and family members—COLLABORATES TO ANALYZE DATA SUCH AS TEST SCORES, WORK SAMPLES, AND OBSERVATIONS TO DECIDE IF ESY SERVICES ARE NECESSARY.

CRITERIA FOR QUALIFICATION

STUDENTS MAY QUALIFY FOR FCPS ESY IF THEY MEET ONE OR MORE OF THE FOLLOWING CONDITIONS:

- DEMONSTRATED SIGNIFICANT REGRESSION IN SKILLS DURING PREVIOUS BREAKS.
- NEED FOR MAINTENANCE OF CRITICAL LIFE SKILLS OR COMMUNICATION ABILITIES.
- RISK OF LOSING PROGRESS IN BEHAVIORAL OR SOCIAL-EMOTIONAL DEVELOPMENT.
- REQUIREMENT OF SPECIALIZED INSTRUCTIONAL SUPPORT THAT CANNOT BE PROVIDED OUTSIDE ESY.
- PRESENCE OF SEVERE DISABILITIES THAT NECESSITATE ONGOING INTERVENTION.

SERVICES OFFERED THROUGH FCPS ESY

FCPS ESY PROGRAMS PROVIDE A BROAD RANGE OF SERVICES TAILORED TO EACH STUDENT'S IEP GOALS. THESE SERVICES FOCUS ON MAINTAINING AND REINFORCING SKILLS RATHER THAN INTRODUCING NEW CONTENT, ENSURING CONTINUITY IN EDUCATION DURING EXTENDED BREAKS.

ACADEMIC INSTRUCTION

ACADEMIC SERVICES INCLUDE TARGETED INSTRUCTION IN CORE SUBJECTS SUCH AS READING, MATH, AND WRITING. THESE LESSONS ARE ADAPTED TO MEET THE STUDENT'S CURRENT PERFORMANCE LEVEL AND ADDRESS AREAS VULNERABLE TO REGRESSION.

RELATED SERVICES

RELATED SERVICES MAY INCLUDE SPEECH THERAPY, OCCUPATIONAL THERAPY, PHYSICAL THERAPY, AND BEHAVIORAL SUPPORT. THESE SERVICES COMPLEMENT ACADEMIC INSTRUCTION AND ADDRESS FUNCTIONAL OR DEVELOPMENTAL NEEDS IDENTIFIED IN THE IEP.

PROGRAM FORMATS

FCPS ESY PROGRAMS ARE OFFERED IN VARIOUS FORMATS TO ACCOMMODATE INDIVIDUAL NEEDS, INCLUDING:

- CENTER-BASED PROGRAMS AT DESIGNATED SCHOOLS.
- HOME-BASED INSTRUCTION FOR STUDENTS UNABLE TO ATTEND SCHOOL.
- COMMUNITY-BASED SERVICES FOCUSING ON LIFE SKILLS.
- VIRTUAL OR HYBRID MODELS WHEN APPLICABLE.

ENROLLMENT AND PLANNING PROCESS

ENROLLMENT IN FCPS ESY REQUIRES CAREFUL PLANNING AND COLLABORATION AMONG THE IEP TEAM, FAMILIES, AND SCHOOL STAFF. THIS PROCESS ENSURES THAT SERVICES ALIGN WITH THE STUDENT'S NEEDS AND ARE DELIVERED EFFECTIVELY DURING THE EXTENDED YEAR PERIOD.

IEP TEAM MEETING

THE IEP TEAM CONVENES TO REVIEW THE STUDENT'S PROGRESS AND DETERMINE ESY ELIGIBILITY. IF ELIGIBLE, THE TEAM DEVELOPS OR UPDATES THE IEP TO INCLUDE SPECIFIC ESY GOALS, SERVICE DELIVERY METHODS, AND SCHEDULES.

PARENTAL INVOLVEMENT

PARENTS OR GUARDIANS PLAY A CRITICAL ROLE IN THE ENROLLMENT PROCESS BY PROVIDING INPUT, CONSENTING TO SERVICES, AND SUPPORTING THEIR CHILD'S PARTICIPATION. COMMUNICATION BETWEEN THE SCHOOL AND FAMILY IS ESSENTIAL FOR SUCCESSFUL IMPLEMENTATION.

REGISTRATION AND SCHEDULING

ONCE ESY ELIGIBILITY IS CONFIRMED, PARENTS RECEIVE INFORMATION ABOUT PROGRAM OPTIONS, SCHEDULES, AND TRANSPORTATION IF APPLICABLE. EARLY REGISTRATION IS ENCOURAGED TO SECURE PLACEMENT IN APPROPRIATE PROGRAMS.

BENEFITS OF FCPS ESY PROGRAMS

PARTICIPATION IN FCPS ESY OFFERS SEVERAL KEY BENEFITS THAT CONTRIBUTE TO THE ACADEMIC AND DEVELOPMENTAL SUCCESS OF STUDENTS WITH DISABILITIES.

SKILL RETENTION

ESY HELPS PREVENT THE LOSS OF ACADEMIC AND FUNCTIONAL SKILLS THAT OFTEN OCCURS DURING LONG BREAKS, MAINTAINING A STEADY TRAJECTORY OF LEARNING AND DEVELOPMENT.

IMPROVED CONFIDENCE AND INDEPENDENCE

ONGOING SUPPORT BOOSTS STUDENTS' CONFIDENCE AND FOSTERS GREATER INDEPENDENCE BY REINFORCING ESSENTIAL SKILLS AND ROUTINES.

CONTINUITY OF SERVICES

ESY ENSURES THAT STUDENTS RECEIVE CONSISTENT SUPPORT WITHOUT INTERRUPTION, REDUCING THE NEED FOR REMEDIATION WHEN THE REGULAR SCHOOL YEAR RESUMES.

FAMILY SUPPORT

FAMILIES BENEFIT FROM STRUCTURED PROGRAMS THAT PROVIDE PROFESSIONAL GUIDANCE AND RESOURCES TO ASSIST IN THEIR CHILD'S EDUCATION OUTSIDE THE STANDARD SCHOOL CALENDAR.

CHALLENGES AND CONSIDERATIONS

WHILE FCPS ESY PROVIDES VALUABLE SUPPORT, THERE ARE CHALLENGES AND CONSIDERATIONS TO ADDRESS TO MAXIMIZE ITS EFFECTIVENESS.

RESOURCE AVAILABILITY

LIMITED STAFFING AND FUNDING CAN IMPACT THE AVAILABILITY AND SCOPE OF ESY SERVICES, SOMETIMES RESTRICTING PROGRAM OPTIONS OR ENROLLMENT CAPACITY.

TRANSPORTATION AND ACCESSIBILITY

ACCESS TO TRANSPORTATION AND PROGRAM LOCATIONS CAN POSE LOGISTICAL CHALLENGES FOR FAMILIES, PARTICULARLY WHEN SERVICES ARE PROVIDED AT CENTRALIZED SITES.

BALANCING REST AND INSTRUCTION

ENSURING STUDENTS RECEIVE NECESSARY INSTRUCTION WHILE ALLOWING ADEQUATE REST AND RECREATION DURING EXTENDED BREAKS IS IMPORTANT TO PREVENT BURNOUT AND MAINTAIN ENGAGEMENT.

INDIVIDUALIZED PLANNING

EACH STUDENT'S NEEDS VARY, REQUIRING FLEXIBLE AND PERSONALIZED APPROACHES TO PROGRAM DESIGN AND DELIVERY TO ACHIEVE OPTIMAL OUTCOMES.

FREQUENTLY ASKED QUESTIONS

WHAT DOES FCPS ESY STAND FOR?

FCPS ESY STANDS FOR FAIRFAX COUNTY PUBLIC SCHOOLS EXTENDED SCHOOL YEAR, WHICH IS A PROGRAM DESIGNED TO PROVIDE ADDITIONAL EDUCATIONAL SERVICES DURING THE SUMMER FOR ELIGIBLE STUDENTS.

WHO IS ELIGIBLE FOR FCPS ESY SERVICES?

STUDENTS WITH DISABILITIES WHO REQUIRE EXTENDED INSTRUCTIONAL TIME TO PREVENT REGRESSION AND MAINTAIN SKILLS AS DETERMINED BY THEIR INDIVIDUALIZED EDUCATION PROGRAM (IEP) TEAM ARE ELIGIBLE FOR FCPS ESY SERVICES.

WHEN DOES FCPS ESY TYPICALLY TAKE PLACE?

FCPS ESY USUALLY TAKES PLACE DURING THE SUMMER MONTHS, OFTEN FROM LATE JUNE THROUGH JULY, BUT SPECIFIC DATES CAN VARY EACH YEAR.

HOW CAN PARENTS APPLY FOR FCPS ESY?

PARENTS CAN DISCUSS ESY ELIGIBILITY DURING THEIR CHILD'S IEP MEETING. IF ESY IS RECOMMENDED, THE SCHOOL WILL PROVIDE INFORMATION ON ENROLLMENT PROCEDURES AND NECESSARY FORMS.

WHAT TYPES OF SERVICES ARE OFFERED IN FCPS ESY?

FCPS ESY OFFERS SPECIALIZED INSTRUCTION, RELATED SERVICES SUCH AS SPEECH THERAPY OR OCCUPATIONAL THERAPY, AND SUPPORTS TAILORED TO THE STUDENT'S IEP GOALS TO HELP MAINTAIN PROGRESS.

IS FCPS ESY MANDATORY FOR ELIGIBLE STUDENTS?

NO, FCPS ESY IS NOT MANDATORY. IT IS RECOMMENDED BASED ON THE STUDENT'S NEEDS, AND PARENTS CAN DECIDE WHETHER TO ENROLL THEIR CHILD IN THE PROGRAM.

ARE FCPS ESY PROGRAMS IN-PERSON OR VIRTUAL?

FCPS ESY PROGRAMS ARE PRIMARILY IN-PERSON TO PROVIDE HANDS-ON SUPPORT, BUT VIRTUAL OPTIONS MAY BE AVAILABLE DEPENDING ON CIRCUMSTANCES OR HEALTH GUIDELINES.

HOW IS FCPS ESY DIFFERENT FROM REGULAR SUMMER SCHOOL?

FCPS ESY IS SPECIFICALLY DESIGNED FOR STUDENTS WITH DISABILITIES TO PREVENT SKILL REGRESSION, FOCUSING ON INDIVIDUALIZED INSTRUCTION ALIGNED WITH THE IEP, WHEREAS REGULAR SUMMER SCHOOL IS TYPICALLY OPEN TO ALL STUDENTS AND FOCUSES ON GENERAL ACADEMIC ENRICHMENT.

CAN TRANSPORTATION BE PROVIDED FOR FCPS ESY?

YES, TRANSPORTATION CAN BE PROVIDED FOR STUDENTS ELIGIBLE FOR FCPS ESY SERVICES IF IT IS INCLUDED AS A RELATED SERVICE IN THEIR IEP.
