OVERVIEW OF FINANCIAL AID AT NOVA SOUTHEASTERN UNIVERSITY

NOVA SOUTHEASTERN UNIVERSITY OFFERS A ROBUST FINANCIAL AID PROGRAM DESIGNED TO SUPPORT STUDENTS FROM DIVERSE ECONOMIC BACKGROUNDS. FINANCIAL AID AT NSU ENCOMPASSES A VARIETY OF FUNDING SOURCES AIMED AT MAKING EDUCATION AFFORDABLE AND ACCESSIBLE. THE UNIVERSITY'S FINANCIAL AID OFFICE WORKS CLOSELY WITH STUDENTS TO IDENTIFY THE BEST COMBINATION OF ASSISTANCE BASED ON INDIVIDUAL CIRCUMSTANCES. THIS SUPPORT ENSURES THAT STUDENTS CAN FOCUS ON THEIR ACADEMIC AND PROFESSIONAL GOALS WITHOUT UNDUE FINANCIAL STRESS. COMPREHENSIVE COUNSELING AND RESOURCES ARE AVAILABLE TO HELP STUDENTS UNDERSTAND THEIR OPTIONS AND RESPONSIBILITIES.

TYPES OF FINANCIAL AID AVAILABLE

STUDENTS AT NOVA SOUTHEASTERN UNIVERSITY HAVE ACCESS TO SEVERAL TYPES OF FINANCIAL AID, EACH SERVING DIFFERENT NEEDS AND ELIGIBILITY REQUIREMENTS. UNDERSTANDING THESE OPTIONS ALLOWS STUDENTS TO PLAN EFFECTIVELY AND MAXIMIZE THEIR AID PACKAGE.

GRANTS

GRANTS ARE A FORM OF GIFT AID THAT DOES NOT REQUIRE REPAYMENT. NSU OFFERS INSTITUTIONAL GRANTS AS WELL AS FACILITATES ACCESS TO FEDERAL AND STATE GRANTS LIKE THE PELL GRANT AND FLORIDA STUDENT ASSISTANCE GRANT. THESE AWARDS ARE TYPICALLY BASED ON FINANCIAL NEED.

SCHOLARSHIPS

SCHOLARSHIPS AT NSU ARE MERIT-BASED OR NEED-BASED AWARDS THAT RECOGNIZE ACADEMIC EXCELLENCE, LEADERSHIP, COMMUNITY SERVICE, OR SPECIFIC TALENTS. MANY SCHOLARSHIPS TARGET SPECIFIC PROGRAMS OR STUDENT DEMOGRAPHICS, PROVIDING TAILORED FINANCIAL SUPPORT.

LOANS

STUDENT LOANS ARE BORROWED FUNDS THAT MUST BE REPAYED WITH INTEREST. NSU ASSISTS STUDENTS IN OBTAINING FEDERAL STUDENT LOANS SUCH AS DIRECT SUBSIDIZED AND UNSUBSIDIZED LOANS, ALONG WITH PRIVATE LOAN OPTIONS. IT IS IMPORTANT TO UNDERSTAND LOAN TERMS TO MANAGE DEBT RESPONSIBLY.

Work-Study Programs

WORK-STUDY PROGRAMS OFFER PART-TIME EMPLOYMENT TO ELIGIBLE STUDENTS, ALLOWING THEM TO EARN MONEY TO HELP COVER EDUCATIONAL EXPENSES. THESE JOBS ARE OFTEN ON CAMPUS AND DESIGNED TO ACCOMMODATE ACADEMIC SCHEDULES.

APPLICATION PROCESS FOR FINANCIAL AID AT NSU

APPLYING FOR FINANCIAL AID AT NOVA SOUTHEASTERN UNIVERSITY INVOLVES SEVERAL STEPS DESIGNED TO COLLECT COMPREHENSIVE FINANCIAL INFORMATION AND ASSESS ELIGIBILITY ACCURATELY.

FREE APPLICATION FOR FEDERAL STUDENT AID (FAFSA)

THE FAFSA IS THE PRIMARY APPLICATION FORM USED TO APPLY FOR FEDERAL, STATE, AND INSTITUTIONAL AID. STUDENTS MUST SUBMIT THE FAFSA ANNUALLY TO BE CONSIDERED FOR MOST TYPES OF AID. NSU'S SCHOOL CODE MUST BE INCLUDED ON THE APPLICATION TO ENSURE PROPER PROCESSING.

NSU FINANCIAL AID APPLICATION

IN ADDITION TO THE FAFSA, NSU MAY REQUIRE STUDENTS TO COMPLETE AN INTERNAL FINANCIAL AID APPLICATION. THIS FORM COLLECTS ADDITIONAL INFORMATION TO TAILOR AID PACKAGES AND VERIFY ELIGIBILITY FOR INSTITUTIONAL SCHOLARSHIPS AND GRANTS.

SUPPORTING DOCUMENTATION

STUDENTS MAY BE ASKED TO PROVIDE TAX RETURNS, PROOF OF INCOME, OR OTHER DOCUMENTATION TO VERIFY FINANCIAL INFORMATION. TIMELY SUBMISSION OF THESE DOCUMENTS IS CRITICAL TO AVOID DELAYS IN AID DISBURSEMENT.

ELIGIBILITY REQUIREMENTS

ELIGIBILITY FOR FINANCIAL AID AT NOVA SOUTHEASTERN UNIVERSITY DEPENDS ON SEVERAL FACTORS, INCLUDING ENROLLMENT STATUS, CITIZENSHIP, ACADEMIC PROGRESS, AND FINANCIAL NEED.

ENROLLMENT STATUS

MOST FINANCIAL AID PROGRAMS REQUIRE STUDENTS TO BE ENROLLED AT LEAST HALF-TIME IN AN ELIGIBLE DEGREE OR CERTIFICATE PROGRAM. FULL-TIME ENROLLMENT MAY BE NECESSARY FOR CERTAIN SCHOLARSHIPS OR GRANTS.

CITIZENSHIP AND RESIDENCY

FEDERAL FINANCIAL AID REQUIRES U.S. CITIZENSHIP OR ELIGIBLE NON-CITIZEN STATUS. STATE AID PROGRAMS TYPICALLY HAVE RESIDENCY REQUIREMENTS, WHILE INSTITUTIONAL AID MAY HAVE VARYING GUIDELINES.

SATISFACTORY ACADEMIC PROGRESS

STUDENTS MUST MAINTAIN SATISFACTORY ACADEMIC PROGRESS (SAP) AS OUTLINED BY NSU POLICIES TO REMAIN ELIGIBLE FOR FINANCIAL AID. THIS INCLUDES MAINTAINING A MINIMUM GPA AND COMPLETING A REQUIRED PERCENTAGE OF ATTEMPTED CREDITS.

FEDERAL AND STATE AID PROGRAMS

NOVA SOUTHEASTERN UNIVERSITY PARTICIPATES IN NUMEROUS FEDERAL AND STATE FINANCIAL AID PROGRAMS THAT PROVIDE GRANTS, LOANS, AND WORK-STUDY OPPORTUNITIES TO QUALIFIED STUDENTS.

FEDERAL PELL GRANT

THE PELL GRANT IS A NEED-BASED GRANT AWARDED TO UNDERGRADUATE STUDENTS WITH EXCEPTIONAL FINANCIAL NEED. IT DOES NOT REQUIRE REPAYMENT AND CAN SIGNIFICANTLY REDUCE OUT-OF-POCKET EXPENSES.

FEDERAL DIRECT LOANS

DIRECT SUBSIDIZED AND UNSUBSIDIZED LOANS ARE AVAILABLE TO ELIGIBLE STUDENTS. SUBSIDIZED LOANS DO NOT ACCRUE INTEREST WHILE THE STUDENT IS IN SCHOOL, WHILE UNSUBSIDIZED LOANS BEGIN ACCRUING INTEREST IMMEDIATELY.

FLORIDA STUDENT ASSISTANCE GRANT

THIS STATE-FUNDED GRANT ASSISTS FLORIDA RESIDENTS ATTENDING NSU. ELIGIBILITY DEPENDS ON FINANCIAL NEED AND ENROLLMENT IN AN ELIGIBLE DEGREE PROGRAM.

INSTITUTIONAL SCHOLARSHIPS AND GRANTS

NOVA SOUTHEASTERN UNIVERSITY OFFERS A VARIETY OF INSTITUTIONAL SCHOLARSHIPS AND GRANTS AIMED AT REWARDING ACADEMIC ACHIEVEMENT AND SUPPORTING STUDENTS WITH FINANCIAL NEED.

MERIT-BASED SCHOLARSHIPS

THESE SCHOLARSHIPS RECOGNIZE HIGH ACADEMIC PERFORMANCE, LEADERSHIP SKILLS, OR OTHER ACHIEVEMENTS. EXAMPLES INCLUDE FRESHMAN MERIT SCHOLARSHIPS AND PROGRAM-SPECIFIC AWARDS.

NEED-BASED GRANTS

NEED-BASED GRANTS FROM NSU HELP BRIDGE THE GAP BETWEEN FINANCIAL NEED AND AVAILABLE RESOURCES. THESE GRANTS REQUIRE DETAILED FINANCIAL INFORMATION AND ARE AWARDED BASED ON DEMONSTRATED NEED.

GRADUATE AND PROFESSIONAL SCHOLARSHIPS

NSU PROVIDES SCHOLARSHIPS SPECIFICALLY FOR GRADUATE AND PROFESSIONAL STUDENTS IN FIELDS SUCH AS LAW, MEDICINE, AND BUSINESS TO SUPPORT ADVANCED EDUCATION COSTS.

STUDENT LOANS AND REPAYMENT OPTIONS

WHILE LOANS CAN BE AN ESSENTIAL PART OF FINANCING EDUCATION, UNDERSTANDING REPAYMENT OPTIONS AND RESPONSIBILITIES IS CRUCIAL FOR FINANCIAL PLANNING.

FEDERAL STUDENT LOANS

FEDERAL LOANS OFFER BENEFITS LIKE FIXED INTEREST RATES AND INCOME-DRIVEN REPAYMENT PLANS. NSU FINANCIAL AID COUNSELORS ASSIST STUDENTS IN SELECTING APPROPRIATE LOAN OPTIONS.

PRIVATE LOANS

PRIVATE LOANS MAY BE USED TO SUPPLEMENT FEDERAL AID BUT OFTEN HAVE HIGHER INTEREST RATES AND FEWER BORROWER PROTECTIONS. CAREFUL CONSIDERATION IS RECOMMENDED BEFORE BORROWING PRIVATELY.

REPAYMENT PLANS

FEDERAL LOAN BORROWERS CAN CHOOSE FROM VARIOUS REPAYMENT PLANS, INCLUDING STANDARD, GRADUATED, AND INCOME-DRIVEN OPTIONS, ALLOWING FLEXIBILITY BASED ON FINANCIAL CIRCUMSTANCES.

WORK-STUDY OPPORTUNITIES AT NSU

THE FEDERAL WORK-STUDY PROGRAM AT NOVA SOUTHEASTERN UNIVERSITY PROVIDES STUDENTS WITH PART-TIME JOB OPPORTUNITIES THAT HELP FINANCE THEIR EDUCATION WHILE GAINING VALUABLE WORK EXPERIENCE.

ELIGIBILITY AND APPLICATION

STUDENTS INTERESTED IN WORK-STUDY MUST INDICATE THEIR INTEREST ON THE FAFSA AND MEET ELIGIBILITY CRITERIA. POSITIONS ARE TYPICALLY ON CAMPUS AND DESIGNED TO COMPLEMENT ACADEMIC COMMITMENTS.

TYPES OF JOBS AVAILABLE

WORK-STUDY JOBS AT NSU MAY INCLUDE RESEARCH ASSISTANTSHIPS, ADMINISTRATIVE SUPPORT, LIBRARY SERVICES, AND COMMUNITY OUTREACH POSITIONS, OFFERING DIVERSE EXPERIENCES TO STUDENTS.

BENEFITS OF WORK-STUDY

BEYOND FINANCIAL SUPPORT, WORK-STUDY HELPS STUDENTS DEVELOP PROFESSIONAL SKILLS, BUILD NETWORKS, AND ENHANCE RESUMES, CONTRIBUTING TO CAREER READINESS AFTER GRADUATION.

TIPS FOR MAXIMIZING FINANCIAL AID BENEFITS

TO MAKE THE MOST OF FINANCIAL AID OPPORTUNITIES AT NOVA SOUTHEASTERN UNIVERSITY, STUDENTS SHOULD ADOPT PROACTIVE STRATEGIES THROUGHOUT THEIR ACADEMIC JOURNEY.

- SUBMIT THE FAFSA EARLY EACH YEAR TO MEET DEADLINES AND MAXIMIZE AID ELIGIBILITY.
- MAINTAIN STRONG ACADEMIC PERFORMANCE TO REMAIN ELIGIBLE FOR SCHOLARSHIPS AND INSTITUTIONAL AID.
- COMMUNICATE REGULARLY WITH THE NSU FINANCIAL AID OFFICE FOR UPDATES AND GUIDANCE.
- EXPLORE ALL SCHOLARSHIP OPPORTUNITIES, INCLUDING EXTERNAL SOURCES, TO SUPPLEMENT AID PACKAGES.
- DEVELOP A REALISTIC BUDGET THAT ACCOUNTS FOR TUITION, FEES, LIVING EXPENSES, AND LOAN REPAYMENT.
- CONSIDER PART-TIME EMPLOYMENT OR WORK-STUDY TO REDUCE RELIANCE ON LOANS.
- REVIEW LOAN TERMS CAREFULLY AND BORROW ONLY WHAT IS NECESSARY TO MINIMIZE FUTURE DEBT BURDEN.
