OVERVIEW AND PURPOSE OF THE FLIGHT CREW OPERATING MANUAL

THE FLIGHT CREW OPERATING MANUAL IS A FUNDAMENTAL DOCUMENT THAT OUTLINES THE OPERATIONAL FRAMEWORK FOR FLIGHT PERSONNEL. REGULATORY COMPLIANCE AND STANDARDS

THE FLIGHT CREW OPERATING MANUAL MUST ALIGN WITH NATIONAL AND INTERNATIONAL AVIATION REGULATIONS TO ENSURE LEGAL COMPLIANCE AND OPERATIONAL SAFETY. FREQUENTLY ASKED QUESTIONS

WHAT IS A FLIGHT CREW OPERATING MANUAL (FCOM)?

THE FCOM INCLUDES NORMAL AND ABNORMAL PROCEDURES, SYSTEM DESCRIPTIONS, PERFORMANCE DATA, LIMITATIONS, CHECKLISTS, EMERGENCY PROCEDURES, AND OPERATIONAL POLICIES RELEVANT TO THE SPECIFIC AIRCRAFT.

IS THE FLIGHT CREW OPERATING MANUAL THE SAME FOR ALL AIRCRAFT?

NO, EACH AIRCRAFT TYPE HAS ITS OWN SPECIFIC FCOM TAILORED TO ITS SYSTEMS, PERFORMANCE, AND OPERATIONAL CHARACTERISTICS, SO PILOTS MUST USE THE MANUAL CORRESPONDING TO THE AIRCRAFT THEY OPERATE.

WHO IS RESPONSIBLE FOR MAINTAINING THE ACCURACY OF THE FCOM?

AIRCRAFT MANUFACTURERS, AIRLINES, AND REGULATORY BODIES COLLABORATE TO MAINTAIN AND UPDATE THE FCOM, WITH THE OPERATOR TYPICALLY RESPONSIBLE FOR DISTRIBUTING CURRENT REVISIONS TO FLIGHT CREWS.

CAN PILOTS PERSONALIZE OR ANNOTATE THE FLIGHT CREW OPERATING MANUAL?

GENERALLY, PILOTS SHOULD NOT MAKE UNAUTHORIZED ANNOTATIONS OR CHANGES TO THE FCOM AS IT IS AN OFFICIAL DOCUMENT. HOWEVER, OPERATORS MAY ALLOW NOTES IN SEPARATE LOGBOOKS OR BRIEFING MATERIALS.

HOW IS THE FCOM DIFFERENT FROM THE AIRCRAFT FLIGHT MANUAL (AFM)?

THE AFM IS A REGULATORY DOCUMENT CONTAINING LEGALLY REQUIRED LIMITATIONS AND PERFORMANCE DATA, WHILE THE FCOM PROVIDES DETAILED OPERATIONAL PROCEDURES AND GUIDANCE TO FLIGHT CREWS, COMPLEMENTING THE AFM.

ARE ELECTRONIC VERSIONS OF THE FCOM AVAILABLE?

YES, MANY AIRLINES AND MANUFACTURERS PROVIDE ELECTRONIC VERSIONS OF THE FCOM, ACCESSIBLE VIA TABLETS OR ONBOARD ELECTRONIC FLIGHT BAGS (EFBs), ALLOWING EASIER UPDATES AND ACCESS FOR FLIGHT CREWS.

HOW DOES THE FCOM SUPPORT HANDLING ABNORMAL AND EMERGENCY SITUATIONS?

THE FCOM INCLUDES SPECIFIC STEP-BY-STEP PROCEDURES AND CHECKLISTS FOR ABNORMAL AND EMERGENCY SITUATIONS, GUIDING FLIGHT CREWS TO RESPOND EFFECTIVELY AND MAINTAIN SAFETY DURING UNEXPECTED EVENTS.
