THE NATIONAL TRANSPORTATION SAFETY BOARD (NTSB) CONDUCTED A THOROUGH INVESTIGATION INTO THE CAUSE OF THE ACCIDENT. THE CRASH SHOCKED THE NATION AND LED TO WIDESPREAD MOURNING GIVEN KOBE BRYANT'S PROMINENCE IN PROFESSIONAL BASKETBALL AND GIANNA BRYANT'S PROMISING FUTURE IN THE SPORT.

VICTIMS OF THE CRASH

THERE WERE NINE INDIVIDUALS ON BOARD THE HELICOPTER, ALL OF WHOM TRAGICALLY PERISHED. THE VICTIMS INCLUDED:

- GIANNA BRYANT, KOBE'S DAUGHTER
- JOHN ALTABELLI, BASEBALL COACH
- KERI ALTABELLI, JOHN'S WIFE
- ALYSSA ALTABELLI, JOHN AND KERI'S DAUGHTER
- CHRISTINA MAUSER, BASKETBALL COACH
- SARAH CHESTER
- ARA ZOBAYAN, HELICOPTER PILOT

- PAYTON CHESTER, SARAH'S DAUGHTER

THIS LIST HIGHLIGHTS THE PROFOUND LOSS EXPERIENCED BY FAMILIES AND COMMUNITIES CONNECTED TO THE VICTIMS.

DETAILS OF THE GIANNA BRYANT AUTOPSY REPORT
