UNDERSTANDING LIDOCAINE ORAL SOLUTION

MECHANISM OF ACTION

THIS BLOCKAGE LEADS TO A LOSS OF SENSATION IN THE TARGETED AREA, MAKING IT AN EFFECTIVE TREATMENT FOR LOCALIZED PAIN RELIEF IN THE MOUTH AND THROAT. COMMON USES

FREQUENCY OF USE

APPLICATION. FOR CHILDREN UNDER 12, THE DOSAGE MUST BE CAREFULLY ADJUSTED BASED ON WEIGHT AND THE HEALTHCARE PROVIDER'S RECOMMENDATIONS.

MAXIMUM DAILY DOSE

TO AVOID TOXICITY, THE TOTAL AMOUNT OF LIDOCAINE ADMINISTERED IN A 24-HOUR PERIOD SHOULD NOT EXCEED THE LIMITS SUGGESTED BY MEDICAL GUIDELINES. - SWELLING OF THE FACE, LIPS, TONGUE, OR THROAT
- DIFFICULTY BREATHING OR SWALLOWING
- SEVERE DIZZINESS OR FAINTING
- IRREGULAR HEARTBEAT OR PALPITATIONS

INTERACTIONS WITH OTHER MEDICATIONS

CONSULTING HEALTHCARE PROVIDERS

PATIENTS SHOULD DISCLOSE ALL CURRENT MEDICATIONS, INCLUDING OVER-THE-COUNTER DRUGS AND SUPPLEMENTS, TO THEIR HEALTHCARE PROVIDER BEFORE STARTING LIDOCAINE ORAL SOLUTION. THIS DISCLOSURE HELPS PREVENT HARMFUL DRUG INTERACTIONS.

STORAGE AND HANDLING

DISPOSAL

UNUSED OR EXPIRED LIDOCAINE ORAL SOLUTION SHOULD BE DISPOSED OF PROPERLY, FOLLOWING LOCAL REGULATIONS OR PHARMACY GUIDELINES, TO AVOID ENVIRONMENTAL CONTAMINATION OR ACCIDENTAL INGESTION.

USE LIDOCAINE ORAL SOLUTION EXACTLY AS PRESCRIBED BY YOUR HEALTHCARE PROVIDER, TYPICALLY NO MORE THAN 4 TIMES A DAY, AND DO NOT EXCEED THE RECOMMENDED DOSE TO AVOID SIDE EFFECTS.

ARE THERE ANY SIDE EFFECTS OF USING LIDOCAINE ORAL SOLUTION?
