INVESCO S&P MIDCAP 400 EQUAL WEIGHT ETF IS A PROMINENT INVESTMENT VEHICLE DESIGNED TO TRACK THE PERFORMANCE OF THE S&P MIDCAP 400 EQUAL WEIGHT INDEX. THIS EXCHANGE-TRADED FUND (ETF) OFFERS INVESTORS EXPOSURE TO MID-CAP U.S. COMPANIES WITH AN EQUAL WEIGHTING APPROACH, DIFFERENTIATING IT FROM TRADITIONAL MARKET-CAP WEIGHTED FUNDS. THE EQUAL WEIGHT STRATEGY AIMS TO PROVIDE A MORE BALANCED RISK AND RETURN PROFILE BY GIVING EACH CONSTITUENT COMPANY THE SAME IMPORTANCE IN THE PORTFOLIO. OVERVIEW OF INVESCO S&P MIDCAP 400 EQUAL WEIGHT ETF

THE INVESCO S&P MIDCAP 400 EQUAL WEIGHT ETF IS DESIGNED TO REPLICATE THE PERFORMANCE OF THE S&P MIDCAP 400 EQUAL WEIGHT INDEX, WHICH CONSISTS OF 400 MID-SIZED U.S. COMPANIES. UNLIKE TRADITIONAL CAPITALIZATION-WEIGHTED ETFs, THIS FUND ASSIGNS AN EQUAL WEIGHT TO EACH STOCK, PROVIDING A UNIQUE APPROACH TO MID-CAP INVESTING. THE ETF IS KNOWN FOR REFLECTING THE BROAD MID-CAP MARKET SEGMENT, WHICH OFTEN REPRESENTS COMPANIES WITH STRONG GROWTH POTENTIAL AND MODERATE VOLATILITY COMPARED TO LARGE-CAP STOCKS. MANAGED BY INVESCO, A WELL-ESTABLISHED ASSET MANAGEMENT FIRM, THE FUND OFFERS INVESTORS A PRACTICAL AND LIQUID MEANS TO GAIN DIVERSIFIED EXPOSURE TO MID-CAP U.S. EQUITIES.

INVESTMENT STRATEGY AND INDEX METHODOLOGY

EQUAL WEIGHTING APPROACH

THE INVESCO S&P MIDCAP 400 EQUAL WEIGHT ETF EMPLOYS AN EQUAL WEIGHTING STRATEGY THAT ASSIGNS THE SAME WEIGHT TO ALL 400 INDEX CONSTITUENTS. THIS CONTRASTS WITH MARKET-CAP WEIGHTED INDICES WHERE LARGER COMPANIES DOMINATE THE PORTFOLIO. EQUAL WEIGHTING REDUCES CONCENTRATION RISK AND ALLOWS SMALLER COMPANIES TO HAVE AN ENHANCED IMPACT ON THE FUND'S PERFORMANCE. THE INDEX IS REBALANCED QUARTERLY TO MAINTAIN EQUAL WEIGHTS, ENSURING CONSISTENT EXPOSURE ACROSS ALL HOLDINGS.

INDEX CONSTRUCTION AND SELECTION CRITERIA

THE UNDERLYING INDEX SELECTS MID-CAP COMPANIES BASED ON MARKET CAPITALIZATION, LIQUIDITY, AND SECTOR

REPRESENTATION. THE S&P MIDCAP 400 EQUAL WEIGHT INDEX IS CONSTRUCTED TO MIRROR THE COMPOSITION OF THE BROADER S&P MIDCAP 400 INDEX BUT APPLIES EQUAL WEIGHTS TO EACH STOCK. THIS METHODOLOGY PROVIDES A BALANCED REPRESENTATION OF THE MID-CAP MARKET SEGMENT, WHICH TYPICALLY INCLUDES COMPANIES WITH MARKET CAPITALIZATIONS RANGING BETWEEN APPROXIMATELY \$3 BILLION AND \$10 BILLION.

PORTFOLIO COMPOSITION AND SECTOR ALLOCATION

THE PORTFOLIO OF THE INVESCO S&P MIDCAP 400 EQUAL WEIGHT ETF IS DIVERSIFIED ACROSS MULTIPLE SECTORS, REFLECTING THE BROAD MID-CAP MARKET. THE EQUAL WEIGHTING APPROACH ENSURES NO SINGLE COMPANY OR SECTOR DOMINATES THE PORTFOLIO, PROVIDING BALANCED SECTOR EXPOSURE. KEY SECTORS OFTEN REPRESENTED IN THIS ETF INCLUDE INDUSTRIALS, FINANCIALS, CONSUMER DISCRETIONARY, INFORMATION TECHNOLOGY, AND HEALTHCARE.

SECTOR BREAKDOWN

- **INDUSTRIALS:** A SIGNIFICANT PORTION OF THE PORTFOLIO IS INVESTED IN INDUSTRIAL COMPANIES, WHICH BENEFIT FROM ECONOMIC GROWTH AND INFRASTRUCTURE DEVELOPMENT.
- **FINANCIALS:** MID-CAP BANKS, INSURANCE FIRMS, AND OTHER FINANCIAL SERVICES MAKE UP A CONSIDERABLE SHARE, OFFERING POTENTIAL INCOME AND GROWTH.
- **CONSUMER DISCRETIONARY:** THIS SECTOR INCLUDES COMPANIES INVOLVED IN RETAIL, LEISURE, AND CONSUMER SERVICES, PROVIDING EXPOSURE TO CONSUMER SPENDING TRENDS.
- **INFORMATION TECHNOLOGY:** MID-SIZED TECH FIRMS CONTRIBUTE INNOVATION AND GROWTH POTENTIAL TO THE PORTFOLIO.
- **HEALTHCARE:** THE HEALTHCARE SECTOR OFFERS DEFENSIVE CHARACTERISTICS AND EXPOSURE TO PHARMACEUTICALS, BIOTECHNOLOGY, AND MEDICAL DEVICES.

PERFORMANCE AND RISK METRICS

PERFORMANCE OF THE INVESCO S&P MIDCAP 400 EQUAL WEIGHT ETF IS INFLUENCED BY THE EQUAL WEIGHTING STRATEGY, WHICH OFTEN LEADS TO DIFFERENT RETURNS COMPARED TO TRADITIONAL MARKET-CAP WEIGHTED MID-CAP ETFs.

HISTORICALLY, EQUAL WEIGHT ETFs HAVE DEMONSTRATED THE POTENTIAL FOR ENHANCED RETURNS DUE TO GREATER EXPOSURE TO SMALLER MID-CAP STOCKS WITHIN THE INDEX. HOWEVER, THIS CAN ALSO RESULT IN INCREASED VOLATILITY AND RISK.

RETURN CHARACTERISTICS

THE ETF TYPICALLY EXHIBITS A BLEND OF GROWTH AND VALUE CHARACTERISTICS, WITH PERFORMANCE DRIVEN BY A BROAD RANGE OF MID-CAP COMPANIES. INVESTORS MAY OBSERVE PERIODS OF OUTPERFORMANCE RELATIVE TO CAP-WEIGHTED BENCHMARKS DURING MARKET PHASES FAVORING SMALLER OR LESS DOMINANT STOCKS.

RISK CONSIDERATIONS

WHILE OFFERING DIVERSIFIED EXPOSURE, THE EQUAL WEIGHT APPROACH CAN INCREASE TURNOVER DUE TO FREQUENT REBALANCING. THIS MAY LEAD TO SLIGHTLY HIGHER TRANSACTION COSTS AND TAX IMPLICATIONS. ADDITIONALLY, MID-CAP STOCKS GENERALLY CARRY MORE RISK THAN LARGE-CAP STOCKS, INCLUDING GREATER SENSITIVITY TO ECONOMIC CYCLES AND MARKET FLUCTUATIONS.

BENEFITS AND DRAWBACKS OF EQUAL WEIGHT ETFs

THE UNIQUE STRUCTURE OF THE INVESCO S&P MIDCAP 400 EQUAL WEIGHT ETF PROVIDES SEVERAL ADVANTAGES BUT ALSO SOME LIMITATIONS. UNDERSTANDING THESE CAN HELP INVESTORS ASSESS IF THE FUND FITS THEIR INVESTMENT OBJECTIVES AND RISK TOLERANCE.

KEY BENEFITS

- **DIVERSIFICATION:** EQUAL WEIGHTING REDUCES CONCENTRATION IN LARGE-CAP STOCKS, SPREADING RISK MORE EVENLY ACROSS HOLDINGS.
- **POTENTIAL FOR OUTPERFORMANCE:** PROVIDES GREATER EXPOSURE TO SMALLER MID-CAP COMPANIES THAT MAY OFFER HIGHER GROWTH PROSPECTS.

POTENTIAL DRAWBACKS

- **HIGHER TURNOVER:** FREQUENT REBALANCING CAN INCREASE TRANSACTION COSTS AND TAX LIABILITIES FOR INVESTORS.
- **INCREASED VOLATILITY:** EXPOSURE TO SMALLER MID-CAP STOCKS MAY RESULT IN GREATER PRICE FLUCTUATIONS.
- **SECTOR BIASES:** DESPITE DIVERSIFICATION, EQUAL WEIGHTING CAN SOMETIMES OVERREPRESENT CERTAIN SECTORS COMPARED TO MARKET-CAP WEIGHTED INDICES.

EXPENSE RATIO AND COSTS

THE EXPENSE RATIO OF THE INVESCO S&P MIDCAP 400 EQUAL WEIGHT ETF IS AN IMPORTANT CONSIDERATION FOR COST-CONSCIOUS INVESTORS. THIS FEE COVERS FUND MANAGEMENT, ADMINISTRATION, AND OPERATIONAL EXPENSES. COMPARED TO ACTIVELY MANAGED FUNDS, THIS ETF GENERALLY OFFERS A COMPETITIVE EXPENSE RATIO, MAKING IT AN EFFICIENT CHOICE FOR MID-CAP EXPOSURE.

INVESTORS SHOULD ALSO BE MINDFUL OF TRADING COSTS AND BID-ASK SPREADS WHEN BUYING OR SELLING ETF SHARES. THE EQUAL WEIGHT STRATEGY'S QUARTERLY REBALANCING CAN LEAD TO SLIGHTLY HIGHER INTERNAL TURNOVER, BUT THIS IS TYPICALLY REFLECTED IN THE FUND'S EXPENSE RATIO RATHER THAN DIRECT COSTS TO INVESTORS.

HOW TO INCORPORATE THE ETF INTO AN INVESTMENT PORTFOLIO

THE INVESCO S&P MIDCAP 400 EQUAL WEIGHT ETF CAN SERVE AS A CORE COMPONENT FOR INVESTORS SEEKING MID-CAP EQUITY EXPOSURE WITH A BALANCED AND DIVERSIFIED APPROACH. ITS EQUAL WEIGHTING METHODOLOGY PROVIDES A DISTINCT ALTERNATIVE TO TRADITIONAL MARKET-CAP WEIGHTED MID-CAP FUNDS, ALLOWING FOR ENHANCED PARTICIPATION IN A BROADER RANGE OF MID-SIZED COMPANIES.

WHAT IS THE INVESCO S&P MIDCAP 400 EQUAL WEIGHT ETF?

THE INVESCO S&P MIDCAP 400 EQUAL WEIGHT ETF (EWMC) IS AN EXCHANGE-TRADED FUND THAT SEEKS TO TRACK THE PERFORMANCE OF THE S&P MIDCAP 400 EQUAL WEIGHT INDEX, PROVIDING EQUAL-WEIGHT EXPOSURE TO MID-CAP U.S. COMPANIES.

HOW DOES THE EQUAL WEIGHT METHODOLOGY AFFECT THE INVESCO S&P MIDCAP 400 EQUAL WEIGHT ETF?

THE EQUAL WEIGHT METHODOLOGY MEANS THAT EACH STOCK IN THE ETF IS ALLOCATED THE SAME WEIGHT, WHICH REDUCES THE INFLUENCE OF THE LARGEST COMPANIES AND INCREASES EXPOSURE TO SMALLER CONSTITUENTS WITHIN THE MID-CAP SEGMENT.

WHAT ARE THE BENEFITS OF INVESTING IN THE INVESCO S&P MIDCAP 400 EQUAL WEIGHT ETF?

BENEFITS INCLUDE DIVERSIFIED EXPOSURE TO MID-CAP STOCKS, REDUCED CONCENTRATION RISK COMPARED TO MARKET-CAP WEIGHTED FUNDS, AND POTENTIAL FOR HIGHER RETURNS DUE TO GREATER EXPOSURE TO SMALLER MID-CAP COMPANIES.
