JAVMA INSTRUCTIONS FOR AUTHORS PROVIDE ESSENTIAL GUIDELINES FOR RESEARCHERS, VETERINARIANS, AND PROFESSIONALS SEEKING TO PUBLISH THEIR WORK IN THE JOURNAL OF THE AMERICAN VETERINARY MEDICAL ASSOCIATION (JAVMA). THESE INSTRUCTIONS ENSURE THAT MANUSCRIPTS MEET THE JOURNAL'S HIGH STANDARDS FOR SCIENTIFIC RIGOR, CLARITY, AND ETHICAL COMPLIANCE. UNDERSTANDING AND ADHERING TO THE JAVMA INSTRUCTIONS FOR AUTHORS FACILITATES A SMOOTH SUBMISSION PROCESS, IMPROVES THE QUALITY OF THE MANUSCRIPT, AND INCREASES THE LIKELIHOOD OF PUBLICATION. THIS ARTICLE OFFERS A COMPREHENSIVE OVERVIEW OF THE KEY COMPONENTS OF THE JAVMA INSTRUCTIONS FOR AUTHORS, INCLUDING MANUSCRIPT PREPARATION, FORMATTING REQUIREMENTS, ETHICAL CONSIDERATIONS, AND SUBMISSION PROTOCOLS. MANUSCRIPT PREPARATION AND FORMATTING

PROPER MANUSCRIPT PREPARATION IS CRITICAL FOR COMPLYING WITH THE JAVMA INSTRUCTIONS FOR AUTHORS. THIS SECTION DETAILS THE STRUCTURAL AND STYLISTIC REQUIREMENTS THAT CONTRIBUTE TO A CLEAR AND PROFESSIONAL PRESENTATION OF RESEARCH FINDINGS AND CLINICAL REPORTS.

GENERAL STRUCTURE OF MANUSCRIPTS

MANUSCRIPTS SUBMITTED TO JAVMA SHOULD FOLLOW A WELL-DEFINED STRUCTURE, TYPICALLY INCLUDING THE FOLLOWING SECTIONS: TITLE PAGE, ABSTRACT, INTRODUCTION, MATERIALS AND METHODS, RESULTS, DISCUSSION, ACKNOWLEDGMENTS, AND REFERENCES. EACH SECTION SERVES A SPECIFIC PURPOSE IN PRESENTING THE RESEARCH COMPREHENSIVELY AND LOGICALLY.

FORMATTING GUIDELINES

JAVMA SPECIFIES PRECISE FORMATTING INSTRUCTIONS TO MAINTAIN CONSISTENCY ACROSS PUBLISHED ARTICLES:

- USE STANDARD AMERICAN ENGLISH, WITH CLEAR AND CONCISE LANGUAGE.
- DOUBLE-SPACE THE ENTIRE MANUSCRIPT, INCLUDING REFERENCES AND FIGURE LEGENDS.
- EMPLOY 12-POINT TIMES NEW ROMAN OR A SIMILAR FONT.
- NUMBER ALL PAGES CONSECUTIVELY, STARTING WITH THE TITLE PAGE.
- LIMIT THE ABSTRACT TO 250 WORDS, SUMMARIZING THE OBJECTIVES, METHODS, RESULTS, AND CONCLUSIONS.

- USE STANDARD ABBREVIATIONS AND DEFINE ANY NONSTANDARD ABBREVIATIONS AT FIRST MENTION.

WORD COUNT AND ARTICLE TYPES

THE JAVMA INSTRUCTIONS FOR AUTHORS SPECIFY DIFFERENT WORD LIMITS DEPENDING ON THE ARTICLE TYPE. ORIGINAL RESEARCH ARTICLES TYPICALLY HAVE A HIGHER WORD COUNT ALLOWANCE THAN CASE REPORTS OR BRIEF COMMUNICATIONS. AUTHORS MUST VERIFY THESE LIMITS TO ENSURE COMPLIANCE BEFORE SUBMISSION.

ETHICAL AND LEGAL CONSIDERATIONS

ADHERENCE TO ETHICAL STANDARDS IS A CORNERSTONE OF THE JAVMA INSTRUCTIONS FOR AUTHORS. THIS SECTION OUTLINES THE NECESSARY DISCLOSURES AND APPROVALS REQUIRED TO UPHOLD RESEARCH INTEGRITY AND PROTECT ANIMAL WELFARE.

ANIMAL USE AND WELFARE

AUTHORS MUST PROVIDE STATEMENTS CONFIRMING THAT ALL ANIMAL USE WAS APPROVED BY AN INSTITUTIONAL ANIMAL CARE AND USE COMMITTEE OR EQUIVALENT ETHICAL REVIEW BOARD. THE JOURNAL REQUIRES COMPLIANCE WITH ACCEPTED GUIDELINES FOR THE HUMANE TREATMENT OF ANIMALS IN RESEARCH AND CLINICAL PRACTICE.

CONFLICT OF INTEREST AND FUNDING DISCLOSURE

FULL DISCLOSURE OF ANY POTENTIAL CONFLICTS OF INTEREST IS MANDATORY. AUTHORS SHOULD ALSO DISCLOSE SOURCES OF FUNDING OR FINANCIAL SUPPORT THAT MAY HAVE INFLUENCED THE RESEARCH OR MANUSCRIPT PREPARATION.

PERMISSIONS AND COPYRIGHT

ANY MATERIAL PREVIOUSLY PUBLISHED OR PROPRIETARY CONTENT USED IN THE MANUSCRIPT MUST HAVE PROPER PERMISSION AND ATTRIBUTION. AUTHORS RETAIN COPYRIGHT BUT GRANT JAVMA THE RIGHT TO PUBLISH AND DISTRIBUTE THE ARTICLE.

FIGURES, TABLES, AND SUPPLEMENTARY MATERIALS

VISUAL AIDS SUCH AS FIGURES AND TABLES PLAY A VITAL ROLE IN ILLUSTRATING RESEARCH FINDINGS. THE JAVMA INSTRUCTIONS FOR AUTHORS PROVIDE DETAILED GUIDANCE ON THE PREPARATION AND SUBMISSION OF THESE MATERIALS TO ENSURE CLARITY AND REPRODUCIBILITY.

FIGURE PREPARATION

FIGURES SHOULD BE SUBMITTED IN HIGH-RESOLUTION FORMATS, PREFERABLY TIFF OR JPEG, WITH A MINIMUM RESOLUTION OF 300 DPI. EACH FIGURE MUST HAVE A CONCISE CAPTION EXPLAINING THE CONTENT CLEARLY. COLOR FIGURES ARE ACCEPTED BUT SHOULD BE MEANINGFUL AND ADD VALUE TO THE ARTICLE.

TABLES

TABLES SHOULD BE SELF-EXPLANATORY AND COMPLEMENT THE TEXT WITHOUT DUPLICATING INFORMATION. THEY MUST BE FORMATTED USING SIMPLE, CLEAR LAYOUTS WITH CONSISTENT FONTS AND SPACING. EACH TABLE REQUIRES A DESCRIPTIVE

TITLE AND FOOTNOTES TO CLARIFY ANY ABBREVIATIONS OR SYMBOLS USED.

SUPPLEMENTARY MATERIALS

ADDITIONAL DATA FILES, VIDEOS, OR EXTENDED DATASETS CAN BE SUBMITTED AS SUPPLEMENTARY MATERIALS. THESE FILES UNDERGO REVIEW BUT ARE PUBLISHED ONLINE ONLY AND NOT INCLUDED IN THE PRINT VERSION. AUTHORS SHOULD ENSURE THAT SUPPLEMENTARY MATERIALS ARE RELEVANT AND ENHANCE THE MANUSCRIPT.

REFERENCES AND CITATION GUIDELINES

ACCURATE CITATION OF SOURCES IS ESSENTIAL FOR ACADEMIC CREDIBILITY AND TO ACKNOWLEDGE PRIOR WORK. JAVMA INSTRUCTIONS FOR AUTHORS SPECIFY THE PREFERRED REFERENCING STYLE AND FORMAT FOR IN-TEXT CITATIONS AND THE REFERENCE LIST.

CITATION STYLE

JAVMA USES A NUMERIC REFERENCING SYSTEM, WITH CITATIONS NUMBERED CONSECUTIVELY IN THE ORDER OF APPEARANCE IN THE TEXT. THE REFERENCE LIST AT THE END OF THE MANUSCRIPT SHOULD CORRESPOND NUMERICALLY TO THE CITATIONS AND INCLUDE COMPLETE BIBLIOGRAPHIC DETAILS.

REFERENCE FORMATTING

REFERENCES MUST INCLUDE ALL AUTHORS' NAMES, ARTICLE TITLES, JOURNAL NAMES ABBREVIATED ACCORDING TO STANDARD CONVENTIONS, PUBLICATION YEAR, VOLUME, AND PAGE NUMBERS. FOR BOOKS, AUTHORS SHOULD LIST THE TITLE, EDITION, PUBLISHER, LOCATION, AND YEAR.

EXAMPLES OF COMMON REFERENCE TYPES

1. JOURNAL ARTICLE: AUTHOR(S). TITLE. JOURNAL ABBREVIATION. YEAR; VOLUME: PAGES.
2. BOOK: AUTHOR(S). TITLE. EDITION. PUBLISHER; YEAR.
3. ONLINE RESOURCES: AUTHOR(S). TITLE. WEBSITE NAME. YEAR. ACCESSED DATE.

SUBMISSION PROCESS AND PEER REVIEW

THE FINAL STAGE IN COMPLYING WITH THE JAVMA INSTRUCTIONS FOR AUTHORS INVOLVES THE MANUSCRIPT SUBMISSION AND PEER REVIEW PROTOCOLS. UNDERSTANDING THESE PROCEDURES FACILITATES TIMELY CONSIDERATION AND PUBLICATION.

MANUSCRIPT SUBMISSION

AUTHORS MUST SUBMIT MANUSCRIPTS ELECTRONICALLY THROUGH THE DESIGNATED SUBMISSION PORTAL, ENSURING ALL REQUIRED FILES AND FORMS ARE COMPLETE AND ACCURATE. THIS INCLUDES THE MANUSCRIPT TEXT, FIGURES, TABLES, COVER LETTER, DISCLOSURES, AND ANY SUPPLEMENTARY MATERIALS.

PEER REVIEW PROCESS

JAVMA ACCEPTS ORIGINAL RESEARCH ARTICLES, CASE REPORTS, REVIEW ARTICLES, CLINICAL COMMUNICATIONS, AND COMMENTARIES, AMONG OTHER TYPES, AS OUTLINED IN THEIR INSTRUCTIONS FOR AUTHORS.

HOW SHOULD REFERENCES BE FORMATTED IN MANUSCRIPTS SUBMITTED TO JAVMA?

REFERENCES IN JAVMA MANUSCRIPTS SHOULD BE FORMATTED ACCORDING TO THE JOURNAL'S SPECIFIC STYLE, WHICH INCLUDES NUMBERED CITATIONS IN THE TEXT AND A REFERENCE LIST FORMATTED AS PER THE INSTRUCTIONS FOR AUTHORS.

WHAT ARE THE REQUIREMENTS FOR FIGURES AND TABLES IN JAVMA SUBMISSIONS?

FIGURES AND TABLES MUST BE CLEAR, PROFESSIONALLY PREPARED, AND SUBMITTED SEPARATELY WITH APPROPRIATE LEGENDS, FOLLOWING THE SPECIFICATIONS DETAILED IN THE JAVMA INSTRUCTIONS FOR AUTHORS.

ARE THERE WORD LIMITS FOR DIFFERENT TYPES OF SUBMISSIONS IN JAVMA?

YES, THE JAVMA INSTRUCTIONS FOR AUTHORS SPECIFY WORD LIMITS DEPENDING ON THE ARTICLE TYPE, SUCH AS SHORTER LIMITS FOR CASE REPORTS AND LONGER FOR ORIGINAL RESEARCH ARTICLES.

DOES JAVMA REQUIRE A SPECIFIC ETHICAL STATEMENT IN SUBMITTED MANUSCRIPTS?

YES, AUTHORS MUST INCLUDE STATEMENTS REGARDING ETHICAL APPROVAL FOR ANIMAL USE OR HUMAN SUBJECTS, AS REQUIRED BY JAVMA'S INSTRUCTIONS FOR AUTHORS.
