THEIR COMMITMENT TO COMMUNITY BENEFIT PROGRAMS, CHARITY CARE, AND HEALTH EQUITY DISTINGUISHES THEM FROM FOR-PROFIT COUNTERPARTS. THE EVOLVING HEALTHCARE LANDSCAPE IN 2022, INFLUENCED BY TECHNOLOGICAL INNOVATIONS AND POLICY REFORMS, CONTINUES TO SHAPE THE STRATEGIES AND OPERATIONS OF THESE SYSTEMS.

TOP NONPROFIT HEALTH SYSTEMS BY SIZE AND REVENUE

- **PROVIDENCE ST. JOSEPH HEALTH:** SERVING COMMUNITIES ACROSS SEVERAL STATES, THIS SYSTEM EMPHASIZES INTEGRATED CARE AND INNOVATIVE HEALTHCARE DELIVERY MODELS.
- **TRINITY HEALTH:** A FAITH-BASED ORGANIZATION WITH A SIGNIFICANT FOOTPRINT, TRINITY HEALTH DELIVERS COMPREHENSIVE CLINICAL SERVICES AND COMMUNITY HEALTH PROGRAMS.
- **UCLA HEALTH:** WHILE MORE REGIONALLY FOCUSED, UCLA HEALTH IS RECOGNIZED FOR ITS ADVANCED MEDICAL RESEARCH AND SPECIALIZED CARE OFFERINGS.

THESE ORGANIZATIONS GENERATE BILLIONS IN ANNUAL REVENUE, WHICH IS REINVESTED IN EXPANDING FACILITIES, ADOPTING NEW TECHNOLOGIES, AND ENHANCING PATIENT SERVICES. THEIR SIZE ALLOWS FOR ECONOMIES OF SCALE AND THE ABILITY TO IMPLEMENT LARGE-SCALE HEALTH INITIATIVES.

COMMONSPIRIT HEALTH

COMMONSPIRIT HEALTH EMERGED AS A POWERHOUSE IN 2022 AFTER THE MERGER OF TWO MAJOR NONPROFIT ENTITIES. IT OPERATES MORE THAN 140 HOSPITALS AND HUNDREDS OF CLINICS, SERVING A BROAD DEMOGRAPHIC. THE SYSTEM FOCUSES ON ADDRESSING SOCIAL DETERMINANTS OF HEALTH AND IMPROVING ACCESS TO CARE IN UNDERSERVED AREAS.

ASCENSION HEALTH

ASCENSION HEALTH REMAINS A LEADER IN THE NONPROFIT HEALTH SECTOR, NOTABLE FOR ITS COMMITMENT TO COMMUNITY HEALTH AND INNOVATION. WITH OVER 150 HOSPITALS, ASCENSION EMPHASIZES HIGH-QUALITY, PATIENT-CENTERED CARE AND INVESTS HEAVILY IN DIGITAL HEALTH SOLUTIONS.

ORGANIZATIONAL STRUCTURE AND SERVICE SCOPE

UNDERSTANDING THE ORGANIZATIONAL STRUCTURES OF THE LARGEST NONPROFIT HEALTH SYSTEMS 2022 REVEALS HOW THEY MANAGE COMPLEX OPERATIONS ACROSS MULTIPLE FACILITIES AND STATES. ADDITIONALLY, MANY OPERATE ACADEMIC MEDICAL CENTERS AFFILIATED WITH UNIVERSITIES, WHICH FACILITATE CUTTING-EDGE RESEARCH AND MEDICAL EDUCATION.

GOVERNANCE AND LEADERSHIP

BOARDS OF TRUSTEES OR DIRECTORS IN NONPROFIT HEALTH SYSTEMS INCLUDE COMMUNITY LEADERS, HEALTHCARE EXPERTS, AND SOMETIMES CLERGY, REFLECTING THE MISSION-DRIVEN NATURE OF THESE ORGANIZATIONS. LEADERSHIP TEAMS PRIORITIZE TRANSPARENCY, ETHICAL PRACTICES, AND ALIGNMENT WITH THE SYSTEM'S CHARITABLE MISSION.

THE LARGEST NONPROFIT HEALTH SYSTEMS PROVIDE DIVERSE CLINICAL SERVICES SUCH AS:

IMPACT ON HEALTHCARE ACCESS AND QUALITY

THE LARGEST NONPROFIT HEALTH SYSTEMS 2022 SIGNIFICANTLY INFLUENCE HEALTHCARE ACCESS AND QUALITY ACROSS THE REGIONS THEY SERVE. THEIR NONPROFIT STATUS MANDATES REINVESTMENT IN COMMUNITY HEALTH INITIATIVES, CHARITY CARE, AND EFFORTS TO REDUCE HEALTH DISPARITIES. THESE SYSTEMS OFTEN LEAD IN IMPLEMENTING QUALITY IMPROVEMENT PROGRAMS AND PATIENT SAFETY PROTOCOLS, CONTRIBUTING TO HIGHER STANDARDS OF CARE.

BY OFFERING A WIDE GEOGRAPHIC REACH AND COMPREHENSIVE SERVICES, THEY IMPROVE ACCESS TO SPECIALTY CARE FOR RURAL AND UNDERSERVED POPULATIONS. ADDITIONALLY, MANY SYSTEMS HAVE INVESTED IN TELEHEALTH PLATFORMS, EXPANDING ACCESS TO CARE BEYOND TRADITIONAL SETTINGS. RECENT TRENDS AND CHALLENGES IN NONPROFIT HEALTH SYSTEMS

IN 2022, THE LARGEST NONPROFIT HEALTH SYSTEMS FACED SEVERAL EMERGING TRENDS AND CHALLENGES THAT SHAPED THEIR OPERATIONS AND STRATEGIC PRIORITIES. REGULATORY COMPLIANCE AND ADAPTING TO EVOLVING HEALTHCARE POLICIES ALSO REQUIRED CONTINUOUS ATTENTION. ON THE POSITIVE SIDE, ADVANCEMENTS IN DIGITAL HEALTH TECHNOLOGIES AND DATA ANALYTICS OFFERED OPPORTUNITIES TO ENHANCE PATIENT ENGAGEMENT AND CARE COORDINATION.

TECHNOLOGICAL INNOVATION
