ELIGIBILITY CRITERIA

TO BE ELIGIBLE FOR PROTECTION UNDER THE LEMON LAW, THE VEHICLE MUST:

- BE A NEW CAR OR LEASED VEHICLE PURCHASED OR LEASED IN SOUTH CAROLINA.
