## UNDERSTANDING THE SCOPE OF NURSING PRACTICE

## HEALTHCARE ENVIRONMENT AND SETTING

## AVAILABLE RESOURCES AND SUPPORT SYSTEMS

WELL-RESOURCED SETTINGS ENABLE NURSES TO UNDERTAKE BROADER ROLES CONFIDENTLY, WHEREAS LIMITED RESOURCES MAY RESTRICT PRACTICE SCOPE. COLLABORATION WITH OTHER HEALTHCARE PROFESSIONALS IS CRITICAL TO OPTIMIZING PATIENT OUTCOMES WITHIN EXISTING RESOURCE CONSTRAINTS.

## MATCHING SCOPE TO CLINICAL SITUATIONS
