UNDERSTANDING MESOTHELIOMA AND ASBESTOS EXPOSURE

THE DISEASE HAS A LONG LATENCY PERIOD, OFTEN DEVELOPING 20 TO 50 YEARS AFTER EXPOSURE.

ASBESTOS EXPOSURE REMAINS A MAJOR CONCERN IN OCCUPATIONAL SETTINGS, ESPECIALLY IN INDUSTRIES INVOLVING HEAVY MACHINERY, MANUFACTURING, AND CONSTRUCTION. - FRICTION MATERIALS IN MACHINERY PARTS

WORKERS INVOLVED IN MANUFACTURING, REPAIRING, OR OPERATING NEW HOLLAND EQUIPMENT WITH THESE COMPONENTS FACED INCREASED RISKS OF ASBESTOS EXPOSURE, LEADING TO MESOTHELIOMA DIAGNOSES DECADES LATER.
