BACKGROUND OF OHSU AND LEGACY HEALTH

OREGON HEALTH & SCIENCE UNIVERSITY (OHSU) IS A LEADING PUBLIC ACADEMIC HEALTH CENTER KNOWN FOR ITS EXTENSIVE MEDICAL RESEARCH, EDUCATION, AND PATIENT CARE SERVICES. LEGACY HEALTH, IN CONTRAST, IS A NOT-FOR-PROFIT HEALTH SYSTEM PROVIDING COMPREHENSIVE HEALTHCARE SERVICES THROUGH A NETWORK OF HOSPITALS AND OUTPATIENT FACILITIES IN THE PORTLAND METROPOLITAN AREA. BOTH ORGANIZATIONS HAVE ESTABLISHED REPUTATIONS FOR HIGH-QUALITY CARE BUT HAVE HISTORICALLY OPERATED INDEPENDENTLY.

THE HISTORY AND MISSION OF EACH INSTITUTION SET THE STAGE FOR THE ACQUISITION. OHSU'S FOCUS ON INNOVATION, CUTTING-EDGE RESEARCH, AND SPECIALIZED MEDICAL SERVICES COMPLEMENTS LEGACY'S STRENGTH IN COMMUNITY-BASED HEALTHCARE AND PRIMARY CARE SERVICES. THIS EXPANSION INCLUDES SPECIALTY CARE, PRIMARY CARE, AND OUTPATIENT SERVICES, WHICH ARE VITAL FOR SERVING A DIVERSE PATIENT POPULATION.

STRENGTHENING FINANCIAL STABILITY
