UNDERSTANDING THE PARTNER'S CAPITAL ACCOUNT ON SCHEDULE K-1

THE PARTNER'S CAPITAL ACCOUNT IS AN INTEGRAL PART OF THE SCHEDULE K-1, WHICH IS USED TO REPORT EACH PARTNER'S SHARE OF INCOME, DEDUCTIONS, CREDITS, AND OTHER FINANCIAL ACTIVITIES WITHIN A PARTNERSHIP. SCHEDULE K-1 IS ISSUED BY PARTNERSHIPS TO THEIR PARTNERS ANNUALLY AND SERVES AS A BASIS FOR THE PARTNER'S INDIVIDUAL TAX REPORTING. THE CAPITAL ACCOUNT REPRESENTS THE PARTNER'S EQUITY INVESTMENT AND CHANGES OVER TIME DUE TO VARIOUS TRANSACTIONS THAT AFFECT THE PARTNER'S OWNERSHIP INTEREST.

DEFINITION AND PURPOSE OF THE CAPITAL ACCOUNT

THE CAPITAL ACCOUNT TRACKS THE VALUE OF A PARTNER'S INVESTMENT IN THE PARTNERSHIP. HOW THE CAPITAL ACCOUNT RELATES TO TAX REPORTING

COMPONENTS OF THE PARTNER'S CAPITAL ACCOUNT

DISTRIBUTIONS TO THE PARTNER

DISTRIBUTIONS REPRESENT WITHDRAWALS OF CASH OR PROPERTY FROM THE PARTNERSHIP TO THE PARTNER. DISTRIBUTIONS DECREASE THE CAPITAL ACCOUNT BALANCE AND REFLECT THE RETURN OF CAPITAL OR PROFITS. PROPER TRACKING OF DISTRIBUTIONS IS ESSENTIAL TO AVOID MISSTATEMENTS IN THE CAPITAL ACCOUNT.

OTHER ADJUSTMENTS

OTHER ADJUSTMENTS INCLUDE ITEMS SUCH AS CONTRIBUTIONS OF PROPERTY WITH LIABILITIES, CHANGES DUE TO REVALUATION OF ASSETS, OR CORRECTIONS OF PRIOR PERIOD ERRORS. THESE ADJUSTMENTS MAY AFFECT THE CAPITAL ACCOUNT AND SHOULD BE CAREFULLY ANALYZED DURING PARTNER'S CAPITAL ACCOUNT ANALYSIS K-1.
