CHARACTERISTICS OF TEMPORARY PROBLEMS

TEMPORARY PROBLEMS ARE TYPICALLY SHORT IN DURATION, SITUATIONAL, AND OFTEN CAUSED BY FACTORS THAT CHANGE OVER TIME. PERSONAL AND SOCIAL CONTEXTS

CONSEQUENCES OF MISAPPLIED PERMANENT SOLUTIONS

- RESOURCE WASTAGE DUE TO UNNECESSARY OR EXCESSIVE INTERVENTIONS
- LOSS OF FLEXIBILITY TO ADAPT TO CHANGING CIRCUMSTANCES
- POTENTIAL CREATION OF NEW PROBLEMS OR COMPLICATIONS
- IRREVERSIBLE DAMAGE TO SYSTEMS, RELATIONSHIPS, OR REPUTATIONS
- REDUCED MORALE AND TRUST AMONG STAKEHOLDERS

PSYCHOLOGICAL AND STRATEGIC FACTORS BEHIND THE APPROACH

THE INCLINATION TO APPLY PERMANENT SOLUTIONS TO TEMPORARY PROBLEMS IS OFTEN DRIVEN BY PSYCHOLOGICAL BIASES AND STRATEGIC MISJUDGMENTS. UNDERSTANDING THESE FACTORS CAN HELP IN RECOGNIZING AND PREVENTING INAPPROPRIATE RESPONSES.

FEAR AND URGENCY

DESIRE FOR CONTROL AND CERTAINTY

PERMANENT SOLUTIONS MAY PROVIDE A SENSE OF CONTROL AND CERTAINTY IN UNCERTAIN SITUATIONS. THE APPEAL OF A DEFINITIVE FIX CAN OVERSHADOW THE BENEFITS OF TEMPORARY OR ADAPTIVE MEASURES.

STRATEGIC MISALIGNMENT
