FOUNDATIONS OF WALKER'S MODEL

THIS APPROACH HAS PROVEN PARTICULARLY EFFECTIVE FOR INDIVIDUALS WITH COMPLEX TRAUMA HISTORIES.

KEY CONCEPTS IN WALKER'S THEORY
