THIS TRANSPARENCY IS CRUCIAL IN QUALITATIVE RESEARCH, WHERE THE RESEARCHER'S PERSPECTIVE CAN SIGNIFICANTLY IMPACT DATA COLLECTION, ANALYSIS, AND CONCLUSIONS.

DEFINITION AND PURPOSE

KEY ELEMENTS OF A POSITIONALITY STATEMENT SAMPLE
