UNDERSTANDING THE PRINCE WILLIAM COUNTY REAL ESTATE TAX BILL

THE PRINCE WILLIAM COUNTY REAL ESTATE TAX BILL REPRESENTS THE ANNUAL CHARGE LEVIED ON PROPERTY OWNERS BASED ON THE ASSESSED VALUE OF THEIR REAL ESTATE. PROPERTY OWNERS RECEIVE OFFICIAL ASSESSMENT NOTICES AND HAVE THE OPPORTUNITY TO REVIEW AND QUESTION THE VALUATION BEFORE TAX BILLS ARE FINALIZED.

ASSESSMENT FREQUENCY AND NOTIFICATION

PRINCE WILLIAM COUNTY CONDUCTS PROPERTY ASSESSMENTS ON AN ANNUAL BASIS, WITH NOTICES TYPICALLY SENT TO PROPERTY OWNERS IN THE SPRING. THESE NOTIFICATIONS PROVIDE THE ESTIMATED MARKET VALUE AND OUTLINE HOW THE

ASSESSMENT WAS DETERMINED. TIMELY REVIEW OF ASSESSMENT NOTICES IS IMPORTANT TO IDENTIFY ANY DISCREPANCIES OR ERRORS THAT COULD AFFECT THE TAX BILL.

FACTORS INFLUENCING PROPERTY VALUE

SEVERAL KEY ELEMENTS AFFECT THE ASSESSED VALUE OF PROPERTIES IN PRINCE WILLIAM COUNTY:

- LOCATION AND NEIGHBORHOOD CHARACTERISTICS
- SIZE AND CONDITION OF STRUCTURES

CURRENT TAX RATES AND CALCULATION METHODS

THE PRINCE WILLIAM COUNTY REAL ESTATE TAX BILL IS CALCULATED BY MULTIPLYING THE ASSESSED VALUE OF A PROPERTY BY THE COUNTY'S CURRENT TAX RATE, EXPRESSED IN DOLLARS PER \$100 OF ASSESSED VALUE. THE BOARD OF SUPERVISORS SETS THE TAX RATE ANNUALLY DURING BUDGET DELIBERATIONS, BALANCING REVENUE NEEDS WITH TAXPAYER IMPACT. IN RECENT YEARS, THE TAX RATE HAS FLUCTUATED TO ACCOMMODATE COUNTY FUNDING PRIORITIES AND ECONOMIC FACTORS.

UNDERSTANDING THE TAX RATE

THE TAX RATE IS A CRUCIAL COMPONENT IN DETERMINING THE TOTAL TAX LIABILITY. FOR EXAMPLE, IF THE TAX RATE IS \$1.20 PER \$100 OF ASSESSED VALUE, A PROPERTY ASSESSED AT \$300,000 WOULD OWE \$3,600 IN REAL ESTATE TAXES. ADDITIONAL LEVIES AND FEES

PAYMENT SCHEDULES AND METHODS

COMMON EXEMPTIONS AVAILABLE

SOME OF THE KEY EXEMPTIONS APPLICABLE IN PRINCE WILLIAM COUNTY INCLUDE:

- **SENIOR CITIZEN TAX RELIEF:** REDUCES TAXES FOR QUALIFIED ELDERLY HOMEOWNERS BASED ON INCOME LIMITS.
- **DISABLED VETERAN EXEMPTION:** PROVIDES PARTIAL OR FULL EXEMPTION FOR VETERANS WITH SERVICE-CONNECTED DISABILITIES.
- **PRIMARY RESIDENCE EXEMPTION:** OFFERS A LOWER TAX RATE OR EXEMPTION FOR OWNER-OCCUPIED HOMES.
- **SURVIVING SPOUSE EXEMPTION:** APPLIES TO SPOUSES OF DISABLED VETERANS OR PUBLIC SAFETY OFFICERS.

HOW TO APPLY FOR EXEMPTIONS

APPLICANTS MUST SUBMIT DOCUMENTATION AND APPLICATIONS TO THE COUNTY'S COMMISSIONER OF THE REVENUE OR RELEVANT DEPARTMENT BY SPECIFIED DEADLINES. VERIFICATION OF ELIGIBILITY CRITERIA IS REQUIRED TO ENSURE ACCURATE APPLICATION OF EXEMPTIONS ON THE TAX BILL.

IMPACT ON REAL ESTATE MARKET AND PROPERTY VALUES

2. GATHER SUPPORTING EVIDENCE SUCH AS RECENT COMPARABLE SALES, APPRAISAL REPORTS, OR DOCUMENTATION OF PROPERTY CONDITIONS.
3. SUBMIT A FORMAL APPEAL APPLICATION TO THE PRINCE WILLIAM COUNTY BOARD OF EQUALIZATION OR THE COMMISSIONER OF THE REVENUE WITHIN THE DESIGNATED TIMEFRAME.
4. ATTEND A HEARING IF REQUIRED, PRESENTING EVIDENCE TO JUSTIFY A LOWER VALUATION.
5. RECEIVE A DECISION, WHICH MAY CONFIRM, REDUCE, OR INCREASE THE ASSESSED VALUE.

TIPS FOR A SUCCESSFUL APPEAL

THOROUGH PREPARATION AND ACCURATE DOCUMENTATION INCREASE THE CHANCES OF A FAVORABLE OUTCOME.
