UNDERSTANDING THE ROLE OF A PROSECUTOR

FREQUENTLY ASKED QUESTIONS

WHAT IS THE ROLE OF A PROSECUTOR IN THE CRIMINAL JUSTICE SYSTEM?

A PROSECUTOR REPRESENTS THE GOVERNMENT IN CRIMINAL CASES, RESPONSIBLE FOR PRESENTING EVIDENCE AGAINST THE ACCUSED AND SEEKING JUSTICE BY PROVING THE DEFENDANT'S GUILT BEYOND A REASONABLE DOUBT.
