IMPACT OF SHARK TANK ON ENTREPRENEURS

YES, WINNERS OR STANDOUT PARTICIPANTS IN READER SHARK TANK OFTEN RECEIVE PUBLISHING CONTRACTS, MENTORSHIP, MARKETING SUPPORT, OR CASH PRIZES TO HELP LAUNCH THEIR WRITING CAREERS.
