IDENTIFYING RIDGEWAY CLOCK MODELS

MANTEL AND WALL CLOCKS

RIDGEWAY ALSO MANUFACTURED SMALLER CLOCKS SUITABLE FOR MANTELPieces OR WALLS. THESE MODELS TEND TO BE LESS EXPENSIVE BUT CAN STILL HOLD SIGNIFICANT VALUE, PARTICULARLY IF THEY INCLUDE SPECIAL FEATURES LIKE WESTMINSTER CHIMES OR HANDCRAFTED DETAILS.

IDENTIFYING MARKS AND LABELS

LOOK FOR RIDGEWAY LABELS, SERIAL NUMBERS, OR MAKER'S MARKS ON THE CLOCK MECHANISM OR CASE. THESE IDENTIFIERS AID IN DATING THE CLOCK AND CONFIRMING ITS AUTHENTICITY, WHICH ARE CRUCIAL FOR ESTABLISHING VALUE.
