EMPLOY PRECISE LANGUAGE SUCH AS "IS SIMILAR TO," "SHARES CHARACTERISTICS WITH," OR "CORRESPONDS TO" TO CLEARLY INDICATE THE RELATIONSHIP. AVOID VAGUE OR AMBIGUOUS TERMS.

STRUCTURE AND CLARITY
