SQE2 PASS RATES

OVERALL SQE PASS RATES

OVERALL SQE PASS RATES, CONSIDERING CANDIDATES WHO PASS BOTH SQE1 AND SQE2, TEND TO BE LOWER THAN INDIVIDUAL STAGE RATES DUE TO THE CUMULATIVE NATURE OF THE ASSESSMENTS. PREPARATION AND TRAINING

EXAM FORMAT AND TIMING
