COMMON CAUSES OF CONSTRUCTION ACCIDENTS IN ST. LOUIS

CONSTRUCTION SITES ARE INHERENTLY DANGEROUS ENVIRONMENTS DUE TO THE NATURE OF THE WORK, THE USE OF HEAVY MACHINERY, AND THE PRESENCE OF NUMEROUS HAZARDS. UNDERSTANDING THE COMMON CAUSES OF CONSTRUCTION ACCIDENTS IS VITAL FOR RECOGNIZING THE LEGAL GROUNDS FOR A CLAIM. IN ST. LOUIS, CONSTRUCTION ACCIDENTS FREQUENTLY RESULT FROM FACTORS SUCH AS UNSAFE WORK CONDITIONS, LACK OF PROPER SAFETY EQUIPMENT, AND NEGLIGENCE ON THE PART OF EMPLOYERS OR CONTRACTORS.

FALLS FROM HEIGHTS

FALLS ARE AMONG THE LEADING CAUSES OF SERIOUS INJURIES AND FATALITIES ON CONSTRUCTION SITES. WORKERS MAY FALL FROM LADDERS, SCAFFOLDS, ROOFS, OR OTHER ELEVATED SURFACES DUE TO UNSTABLE PLATFORMS, MISSING GUARDRAILS, OR FAILURE TO USE FALL PROTECTION SYSTEMS.

EQUIPMENT AND MACHINERY ACCIDENTS

HEAVY MACHINERY SUCH AS CRANES, FORKLIFTS, AND BULLDOZERS POSE SIGNIFICANT RISKS. ACCIDENTS MAY OCCUR DUE TO MECHANICAL FAILURE, OPERATOR ERROR, OR INADEQUATE TRAINING. WORKERS CAN BE CRUSHED, STRUCK BY MOVING EQUIPMENT, OR CAUGHT IN MACHINERY.

ELECTROCUTIONS AND ELECTRICAL HAZARDS

CONSTRUCTION WORKERS OFTEN WORK NEAR LIVE ELECTRICAL WIRES OR OPERATE ELECTRICAL TOOLS. IMPROPER GROUNDING, EXPOSED WIRING, AND CONTACT WITH POWER LINES CAN LEAD TO ELECTROCUTION INJURIES.

EXPOSURE TO HAZARDOUS MATERIALS

MANY CONSTRUCTION SITES INVOLVE THE USE OF CHEMICALS, ASBESTOS, OR OTHER HARMFUL SUBSTANCES. PROLONGED EXPOSURE WITHOUT PROPER PROTECTIVE GEAR CAN CAUSE RESPIRATORY ISSUES, SKIN CONDITIONS, OR LONG-TERM ILLNESSES.

TYPES OF COMPENSATION

- MEDICAL EXPENSES INCLUDING HOSPITAL BILLS AND REHABILITATION COSTS
- LOST WAGES AND LOSS OF EARNING CAPACITY
- PAIN AND SUFFERING DAMAGES
- PERMANENT DISABILITY COMPENSATION
- DEATH BENEFITS FOR FAMILIES OF DECEASED WORKERS

STATUTE OF LIMITATIONS
