

THE ALLEGED FATHER IS NOT EXCLUDED

THE DIFFERENCE BETWEEN "EXCLUDED" AND "NOT EXCLUDED"

UNDERSTANDING THE DISTINCTION BETWEEN EXCLUSION AND NON-EXCLUSION IS FUNDAMENTAL IN INTERPRETING PATERNITY TEST RESULTS.
