- LUNG CANCER – INCREASED RISK PARTICULARLY AMONG SMOKERS EXPOSED TO ASBESTOS
- PLEURAL PLAQUES AND THICKENING – INDICATORS OF ASBESTOS EXPOSURE

THESE HEALTH EFFECTS OFTEN DEVELOP AFTER PROLONGED OR INTENSE EXPOSURE AND MAY NOT MANIFEST UNTIL DECADES LATER, COMPLICATING LEGAL CLAIMS.

LEGAL FRAMEWORK GOVERNING ASBESTOS IN WEST POINT
