ORAL TRADITIONS AND THE EVOLUTION OF STORIES

MECHANISMS OF STORY EVOLUTION

- SELECTIVE EMPHASIS ON HEROIC OR MEMORABLE DETAILS

THE ROLE OF MEMORY AND IDENTITY
