MANY SHOPPING MALLS WHERE FOREVER 21 STORES OPERATE. THE OWNERSHIP FOCUS SHIFTED TOWARD REVITALIZING THE BRAND AND INTEGRATING E-COMMERCE WITH PHYSICAL RETAIL LOCATIONS.

## SHAQUILLE O'NEAL'S ROLE AND INVESTMENTS
