OVERVIEW OF THE TEXAS PENAL CODE

PURPOSE AND SCOPE

- THIRD DEGREE FELONIES – PUNISHABLE BY 2 TO 10 YEARS AND FINES UP TO \$10,000.
- STATE JAIL FELONIES – PUNISHABLE BY 180 DAYS TO 2 YEARS IN A STATE JAIL FACILITY AND FINES UP TO \$10,000.

MISDEMEANORS

MISDEMEANORS ARE LESS SEVERE OFFENSES CLASSIFIED INTO THREE CATEGORIES:

- CLASS A MISDEMEANORS – PUNISHABLE BY UP TO 1 YEAR IN COUNTY JAIL AND FINES UP TO \$4,000.
- CLASS B MISDEMEANORS – PUNISHABLE BY UP TO 180 DAYS IN JAIL AND FINES UP TO \$2,000.
- CLASS C MISDEMEANORS – PUNISHABLE BY FINES UP TO \$500; NO JAIL TIME.

INFRACTIONS AND VIOLATIONS

SOME MINOR OFFENSES, OFTEN TRAFFIC-RELATED OR REGULATORY, ARE CONSIDERED INFRACTIONS OR VIOLATIONS AND USUALLY RESULT IN FINES WITHOUT JAIL TIME. THESE ARE NOT CRIMINAL OFFENSES BUT MAY CARRY ADMINISTRATIVE PENALTIES.

COMMON CRIMES AND KEY PROVISIONS

THE TEXAS PENAL CODE COVERS A BROAD SPECTRUM OF CRIMES, EACH WITH SPECIFIC ELEMENTS THAT MUST BE PROVEN FOR CONVICTION. UNDERSTANDING THESE COMMON OFFENSES IS ESSENTIAL FOR INTERPRETING RELEVANT LEGAL STATUTES.

OFFENSES AGAINST PERSONS

THIS CATEGORY INCLUDES CRIMES THAT DIRECTLY HARM INDIVIDUALS OR THREATEN THEIR SAFETY. EXAMPLES INCLUDE:

- **ASSAULT AND AGGRAVATED ASSAULT:** INTENTIONALLY CAUSING BODILY INJURY OR THREATENING HARM WITH A DEADLY WEAPON.

- **HOMICIDE AND MURDER:** UNLAWFUL KILLING OF ANOTHER PERSON, WITH DISTINCTIONS BASED ON INTENT AND CIRCUMSTANCES.
- **SEXUAL OFFENSES:** CRIMES INVOLVING NON-CONSENSUAL SEXUAL CONDUCT, INCLUDING SEXUAL ASSAULT AND INDECENCY WITH A CHILD.

OFFENSES AGAINST PROPERTY

THESE CRIMES INVOLVE THE UNLAWFUL TAKING, DAMAGING, OR DESTRUCTION OF PROPERTY. COMMON OFFENSES INCLUDE:

- **THEFT:** UNLAWFUL APPROPRIATION OF PROPERTY WITH INTENT TO DEPRIVE THE OWNER.
- **BURGLARY:** ENTERING A BUILDING OR HABITATION WITHOUT CONSENT TO COMMIT A FELONY OR THEFT.
- **CRIMINAL MISCHIEF:** INTENTIONAL DAMAGE TO TANGIBLE PROPERTY.

DRUG-RELATED OFFENSES

THE PENAL CODE CONTAINS NUMEROUS PROVISIONS TARGETING THE MANUFACTURE, POSSESSION, DISTRIBUTION, AND TRAFFICKING OF CONTROLLED SUBSTANCES. PENALTIES VARY DEPENDING ON THE TYPE AND AMOUNT OF DRUG INVOLVED.

PENALTIES AND SENTENCING GUIDELINES

THE TEXAS PENAL CODE ESTABLISHES DETAILED SENTENCING GUIDELINES THAT CORRESPOND TO THE CLASSIFICATION OF OFFENSES. THESE GUIDELINES ENSURE CONSISTENT PUNISHMENT AND PROVIDE A LEGAL FRAMEWORK FOR JUDGES DURING SENTENCING.

FINES AND IMPRISONMENT

PROBATION AND COMMUNITY SUPERVISION

IN CERTAIN CASES, COURTS MAY IMPOSE PROBATION OR COMMUNITY SUPERVISION AS AN ALTERNATIVE TO INCARCERATION. THIS ALLOWS OFFENDERS TO SERVE THEIR SENTENCE UNDER SUPERVISION WHILE ENGAGING IN REHABILITATION OR COMMUNITY SERVICE.

ENHANCEMENTS AND REPEAT OFFENDERS

THE TEXAS PENAL CODE PROVIDES FOR ENHANCED PENALTIES IF THE OFFENDER HAS PRIOR CONVICTIONS OR IF THE CRIME INVOLVED AGGRAVATING FACTORS. REPEAT OFFENDERS MAY FACE LONGER SENTENCES OR HIGHER FINES AS A RESULT OF THESE ENHANCEMENTS.

DEFENSES UNDER THE TEXAS PENAL CODE

THE PENAL CODE AND RELATED CASE LAW RECOGNIZE VARIOUS DEFENSES THAT CAN NEGATE OR MITIGATE CRIMINAL LIABILITY. UNDERSTANDING THESE DEFENSES IS VITAL FOR LEGAL STRATEGY AND ENSURING FAIR TRIALS.

SELF-DEFENSE AND DEFENSE OF OTHERS

TEXAS LAW PERMITS INDIVIDUALS TO USE REASONABLE FORCE TO PROTECT THEMSELVES OR OTHERS FROM IMMINENT HARM. THE CODE OUTLINES CONDITIONS UNDER WHICH SELF-DEFENSE IS JUSTIFIED, INCLUDING THE USE OF DEADLY FORCE IN CERTAIN CIRCUMSTANCES.

INSANITY AND MENTAL ILLNESS

A DEFENDANT MAY ASSERT AN INSANITY DEFENSE IF MENTAL ILLNESS PREVENTED THEM FROM UNDERSTANDING THE NATURE OF THEIR ACTIONS OR DISTINGUISHING RIGHT FROM WRONG AT THE TIME OF THE OFFENSE.

DURESS AND MISTAKE OF FACT

DURESS INVOLVES COMMITTING A CRIME UNDER THREAT OF IMMEDIATE HARM, WHICH MAY EXCUSE LIABILITY. SIMILARLY, A REASONABLE MISTAKE OF FACT CAN NEGATE THE REQUIRED CRIMINAL INTENT IN SOME CASES.

PROCEDURAL ASPECTS AND ENFORCEMENT

THE TEXAS PENAL CODE INTERACTS WITH PROCEDURAL LAWS THAT GOVERN INVESTIGATIONS, ARRESTS, AND TRIALS. ENFORCEMENT AGENCIES AND COURTS APPLY THESE RULES TO ENSURE LAWFUL AND EFFECTIVE ADMINISTRATION OF JUSTICE.

ARREST AND SEARCH PROCEDURES

THE CODE WORKS ALONGSIDE CONSTITUTIONAL PROTECTIONS REGULATING ARRESTS AND SEARCHES TO PREVENT UNLAWFUL DETENTION OR EVIDENCE COLLECTION. PROPER PROCEDURES ARE CRUCIAL FOR UPHOLDING DEFENDANTS' RIGHTS.

CHARGING AND PROSECUTION
