## BRUCE METZGER: LIFE AND SCHOLARLY CONTRIBUTIONS

### LECTIO DIFFICILIOR POTIOR

ONE OF METZGER'S NOTABLE PRINCIPLES IS THE PREFERENCE FOR THE MORE DIFFICULT READING IN TEXTUAL VARIANTS. THIS PRINCIPLE OPERATES ON THE ASSUMPTION THAT SCRIBES WERE MORE LIKELY TO SIMPLIFY OR HARMONIZE DIFFICULT PASSAGES RATHER THAN INTRODUCE HARDER READINGS INTENTIONALLY. CONSEQUENTLY, THE MORE CHALLENGING OR LESS SMOOTH READING OFTEN REPRESENTS THE ORIGINAL TEXT BEFORE EDITORIAL SMOOTHING.

### EXTERNAL AND INTERNAL EVIDENCE

- **LECTIONARIES:** MANUSCRIPTS ARRANGED FOR CHURCH READINGS, PROVIDING ADDITIONAL TEXTUAL DATA.

## TRANSMISSION AND SCRIBAL PRACTICES
